On October 26, 2009, NBTC proposed various modifications to its Tariff F.C.C. No. 1. The modifications were to update the Basic Channel Description for Analog Video Service in order to standardize the descriptions for analog video services in all AT&T regional companies. Transmittal 202 is scheduled to become effective on November 10, 2009.

With this filing, NBTC wishes to withdraw the tariff material filed under Transmittal 202, without its becoming effective, and to restore currently effective material in order to review issues identified in the proposed modification and to ensure that there is no loss in functionality to customers as a result of the verbiage standardization.
