On October 26, 2009, BellSouth proposed various modifications to its Tariff F.C.C. No. 1. The modifications were to update the Basic Channel Description for Broadcast Quality Video Analog Service in order to standardize the descriptions for analog video services in all AT&T regional companies. Transmittal 1188 is scheduled to become effective on November 10, 2009.

With this filing, BellSouth wishes to withdraw the tariff material filed under Transmittal 1188, without its becoming effective, and to restore currently effective material in order to review issues identified in the proposed modification and to ensure that there is no loss in functionality to customers as a result of the verbiage standardization.
