7.2 Service Descriptions (Cont'd)

7.2.5 Video (a.k.a. BellSouth SPA Video) Services

The Telephone Company provides the following video services.

7.2.5.1 Broadcast Quality Video (a.k.a. BellSouth SPA Broadcast Quality Video) Service

(A) Basic Channel Description

Broadcast Quality Video (a.k.a. BellSouth SPA Broadcast Quality Video) service provides one-way transmission of National Television Systems Committee (NTSC) ⁽¹⁾ video signals between customer designated premises or between a customer designated premises and a Telephone Company central office via fiber optic facilities. A NTSC video channel provides standard 525 line/60 field, System M video signal with four (4) associated 20 kHz audio signals. The bandwidth for NTSC channels is either 30 Hz to 4.5 MHz or 30 Hz to 6.6 MHz. The associated audio signals may be either diplexed or provided as separate channels. The provision and the bandwidth of the associated audio signals is a function of the channel interface selected by the customer.

Different rates and charges apply for the two types of video signals. NTSC ⁽¹⁾ channels are provided under a month to month rate option.

Broadcast Quality Video customers may upgrade to Broadcast Quality Video SDI or higher video services without incurring termination liability charges, subject to the following conditions:

- (1) The customer must issue a disconnect order for the existing Broadcast Quality Video Service and place a service order for the new higher speed video service at the same locations such that there is no more than 60 days overlap between the two services.
- (2) The same locations must be utilized for the new higher-speed video service.
- (3) The customer must subscribe to a new CSPP term that is greater than or equal to the remaining months in the existing term for the lower speed service.
- (4) The existing Broadcast Quality Video Service must have been in service for a minimum period of 15 months for a 3-year term, or 18 months for a 5-year term.
- (5) Nonrecurring charges will apply where applicable.

7.4.31 Broadcast Quality Video (a.k.a. BellSouth SPA Broadcast Quality Video) Service (cont'd)

Customers under a CSPP may upgrade to Modular Video Transport Service under a CSPP without incurring any termination charges when:

- (a) the completed service period is 12 months, or 25% of the length of the originally selected CSPP service period, whichever is greater, and
- (b) the service period of the new CSPP arrangement for Modular Video Transport Service is equal to or longer than the remaining service period of the disconnected Commercial Quality Video Service, and
- (c) the service orders to install service under Modular Video Transport Service and disconnect service under Commercial Quality Video Service are related together and received by the Telephone Company at the same time, and there is no lapse in service between installation of Modular Video Transport Service and the disconnection of Commercial Quality Video Service.
