21.22.1	Scope	
	(A) Contract Tariff Option 30, is an offering for new installations of a Dedicated OC48 Ring Service ordered during a specific time period (Service Period) and connecting two premises or wire centers in Hawaii.	
	(B) The regulations, terms and conditions provided in this Section 21.22 apply to Customers who subscribe to Contract Tariff Option 30 during the Service Order Period specified below.	
21.22.2	Eligible Services	
	This is an offering exclusively for new installations of one (1) OC48 Ring Service between wire centers on the island Oahu of as provided in Section 21.22.5(A) following.	
21.22.3	Serving Area	
	The serving areas for the OC48 route of this option is comprised of the Customer's point of presence served from the Mililani and Honolulu wire centers.	
21.22.4	Eligibility Requirements	
	All of the following requirements must be satisfied to be eligible for subscription to Contract Tariff Option 30.	
	(A) Customers who wish to subscribe to the OC48 Ring Service must do so by submitting a written authorization in a manner designated by the Telephone Company during the Service Order Period which ends on December 31, 2009.	
	(B) The eligible OC48 Ring Service and associated rate elements described in Section 21.22.2 preceding and Section 21.22.5(A) following must be ordered on a term plan as allowed for by Hawaiian Telcom.	
	(C) The Customer must accept service on the original service date. If the Customer does not accept service on the original service date, any change to a later date will make the service ineligible for the discount, unless the change is initiated by the Telephone Company.	(N)

21.22.4 Eligibility Requirements, (cont'd.)

- (D) A new service cannot be a service that was disconnected from another contract option, discount plan, or tariff arrangement in order to include that service in this Contract Tariff Option 30.

21.22.5 Description of the Plan

- (A) The OC48 Ring Service offers the Customer the discounted rates set forth below for the specified Service Term of sixty (60) months. Except for service provided under another contract tariff in this Section 21 for which minimum revenue or total revenue is measured on a contract level basis, or a term plan as described under Section 5.7 preceding, service subscribed to under this tariff is not eligible for any other service, term or volume discount for services offered under Contract Tariff Option 30.

(B) Changes to Service During the Service Term

Any additions ordered after the Service Order Period ends will be billed at the then effective tariffed rates as set forth in Section 5.7 preceding, and as such shall not be eligible under this Contract Tariff Option.

21.22.6 Terms and Conditions

The Customer may cancel services prior to the expiration of the Service Term and early Termination Charges will not be applicable. The Company waives all applicable Termination Charges or penalties pursuant to its FCC Tariff No. 1 for this service.

Unless superseded by the terms and conditions set forth herein, all terms and conditions, including termination liability and minimum periods, as stated in Section 5.7 preceding, apply to this Contract Tariff Option 30 service.

21.22.6 Terms and Conditions, (cont'd.)

- (A) Upon subscription, as set forth in Section 21.22.4 preceding, the Customer shall commit to a Service Term of sixty (60) months.
- (B) Except as otherwise excused under the Company's applicable filed and effective tariffs for this service, the Customer shall pay the Company termination charges equal to the following percentage of the applicable monthly rate multiplied by the number of months remaining in the unexpired portion of the Service Term year(s) shown. Any such Termination Charge shall be due and payable in one lump sum within thirty (30) days of billing.

<u>Remaining Months in the following years</u>	<u>Applicable Termination Percentage</u>
First Year	100%
Second Year	50%
Third Year and Beyond	25%

- (C) Replacements, rearrangements, or any other physical change to the minimum services under the Contract Tariff Option 30 will result in termination of the discount rate included in Contract Tariff Option 30 as described in Section 21.22.5 preceding.
