The Verizon Telephone Companies (Verizon) hereby apply for Special Permission for a waiver of Sections 61.58 and 61.59 of the Commission's rules.

Following discussions with the Commission Staff, Verizon is withdrawing revisions originally filed under Transmittal No. 1058 prior to them becoming effective on December 26, 2009, and reinstating the regulations that are presently in effect. Transmittal No. 1058 was filed on December 11, 2009, to revise regulations for the discontinuance of access service.

Verizon wishes to withdraw certain revisions proposed under Transmittal No. 1058 and reinstate material presently in effect. As a result, Verizon requests special permission to waive the requirements of Sections 61.58 and 61.59 of the Commission's rules in order to withdraw certain material pending under Transmittal No. 1058 prior to its scheduled effective date of December 26, 2009.

This application and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).
