Verizon is submitting tariff pages to revise the method in which a Minimum Period Charge is calculated for customers who purchase service under a Term Pricing Plan, Service Discount Plan, Commitment Discount Plan, or National Discount Plan (when plan applies a discount percentage against a monthly or base rate).

Also with this filing, Verizon is increasing certain Special Access rates and charges. The net effect of the changes in this filing is an overall Price Cap revenue reduction of \$18,913.

Support material as specified under Section 61.49 of the Commission's rules is included with this filing.

This transmittal letter and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).
