Following discussions with the Commission Staff, and under authority of Special Permission No. 09-033 of the FCC, Verizon is withdrawing revisions originally filed under Transmittal No. 1063 prior to them becoming effective on January 5, 2010, and reinstating the regulations that are presently in effect. Transmittal No. 1063 was filed on December 21, 2009, to revise Billing Name and Address (BNA) in Tariff FCC Nos. 1 and 11 and to remove obsolete reporting options in Tariff FCC Nos. 14 and 16.
