This charge applies per multiplexing arrangement ordered and is dependent upon the type of multiplexing performed. (DS1 to Voice or DS3 to DS1). This charge also applies whether the multiplexing arrangement is installed coincident with the initial installation or at anytime subsequent to the installation of service.
