On June 20, 2010, AT&T Corp. ("AT&T") tendered a Data Request to JSI seeking additional cost information related to the Annual JSI Interstate Access Tariff Filing ("JSI Tariff Filing") filed with the FCC on June 16, 2010. As a result of this inquiry, it was determined that rate revisions for both Fort Mill Telephone Company ("Fort Mill") and Rock Hill Telephone Company ("Rock Hill") were warranted due to an overstated projection of switching expenses. The revision downward of expenses effected, in turn, reductions in the original Transmittal No. 152 revenue requirements for Switched Access for both Fort Mill and Rock Hill, and a very slight increase for Special Access/Public Packet Data Network for Fort Mill only. The revised revenue requirements applied to the originally filed projected demand has produced the proposed revised rates as reflected on the proposed tariff pages provided in this filing. The aforementioned revisions have been forwarded to and reviewed by AT&T.

On June 24, 2010, JSI filed an Application for a Limited Waiver of Sections 61.59 and 61.58 of the Commission's rules. A waiver of Section 61.59 will allow JSI to file revisions to rates prior to those rates having been in effect for 30 days, in order to revise the rates filed under Transmittal No. 152 to reflect the reductions in revenue requirements mentioned above. A waiver of Section 61.58 of the Commission's rules will allow the revised rates to become effective on less than 15 or, as the case may be, 7 days' notice. On June 29, 2010, the FCC granted JSI's request for a waiver of the noted Commission rules to allow for this filing under the authority of Special Permission No. 10-014.

JSI, Fort Mill and Rock Hill all recognize that the filing made under a transmittal filed under the authority of Special Permission will not be deemed lawful.

In accordance with the Commission's March 31, 2010 release entitled In the Matter of July 1, 2010 Annual Access Charge Tariff Filings, WCB/Pricing File No. 10-03, Order, DA 10-505, the instant filing includes proposed revised rates for the provision of the applicable Switched Access, Special Access, and Public Packet Data Network services offered by the relevant issuing carriers. Additionally, material required pursuant to In the Matter of Material to be Filed in Support of 2010 Annual Access Tariff Filings, WCB/Pricing File No. 10-04, Tariff Review Plans, DA 10-506 (released March 31, 2010) is included in this filing.

Pursuant to Section 61.32(b) of the Commission's Rules, the original of this letter, Form 159, and a check for \$815.00 have been sent via overnight delivery to U.S. Bank, St. Louis, Missouri, as of this date.

Customers will be notified of the proposed changes in accordance with the Commission's requirements.
