The Verizon Telephone Companies (Verizon) hereby apply for Special Permission for a waiver of Section 61.74 of the Commission's Rules.

Verizon intends to introduce a new service in its Access Service Tariff FCC No. 1 (FCC1), Access Service Tariff FCC No. 11 (FCC11), Facilities for Interstate Access Tariff FCC No. 14 (FCC14), and Access Service Tariff FCC No. 16 (FCC16). The new service is a DS3 Premises Multiplexer that allows a DS3 High Capacity Service to be ordered with a DS3 to DS1 multiplexer located at a customer designated premises at which up to twenty-eight DS1 channels may be derived and terminated at that same customer designated premises.

Verizon requests special permission to waive the requirements of Section 61.74 of the Commission's Rules in order to allow FCC1 and FCC11 to reference each other, and FCC14 and FCC16 to reference FCC1 and FCC11, for the purpose of including the DS3 Premises Multiplexer rate element in the list of rate elements that are discounted under Verizon's National Discount Plan.

This application and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).
