Cincinnati Bell Telephone (CBT) hereby applies for Special Permission pursuant to Section 61.51 of the Commission's Rules for waiver of Sections 61.58 (Notice Requirements) and 61.59 (Effective Period Required Before Changes) on not less than 1 day's notice in order to withdraw the tariff material which was filed on pages 331 and 332 with Transmittal No. 847 which were filed on an improper notice period and to restore tariff pages 331 and 332 to those in effect prior to Transmittal No. 847.

On July 22, 2010, CBT filed Transmittal No. 847 to become effective on July 23, 2010. In Transmittal No. 847, pages 331 and 332 reflected incorrect issue and effective dates.

CBT respectfully requests permission to waive Sections 61.58 and 61.59 of the Commission's Rules to allow CBT to withdraw the tariff revisions proposed on pages 331 and 332 of Transmittal No. 847 and to restore the tariff pages currently in effect. CBT wishes to withdraw the proposed revisions in order to allow CBT to revise the issue and effective dates of the pages. Attached are the illustrative tariff pages.
