The accompanying tariff material, issued by Frontier Telephone Companies ("Frontier") and bearing FCC No. 7, is scheduled to become effective August 21, 2010. This tariff material is sent to you for filing in compliance with the Communications Act of 1934, as amended. Supporting material as specified under Section 61.38 of the Commission's Rules is included with this filing.

With this filing, Frontier is providing for Special Construction of facilities to provision tariffs for services in Tariff FCC No. 7 for eight total customer locations for: MI-Verizon Business Network Systems Inc.; OR-United States Cellular Corporation; IL-Verizon Business Network Services, Inc.; North Carolina, Level 13 Communications, LLC; IN-Qwest Communications Company LLC and US Signal Company LLC.
