This filing, issued under authority of Special Permission No. 10-017 of the Federal Communications Commission, introduces a DS3 Premises Multiplexer in Tariff FCC Nos. 1, 11, 14 and 16. The DS3 Premises Multiplexer will be provided by Verizon and will be located within Verizon's communications facilities (i.e., within Verizon's network) and on Verizon's side of the point of termination (demarcation point). The DS3 Premises Multiplexer allows up to twenty-eight DS1 channels to be derived and terminated at that same customer designated premises.

Supporting material as described under Section 61.49 of the Commission's rules is not required with this filing. However, Figure 1, provided as an attachment to this filing, will be used in the 2011 Annual Filing to demonstrate that the new rate elements being introduced in FCC Nos. 1, 11, and 14 should be granted the same Phase I or Phase II regulatory relief in the MSAs and the non-MSAs where the service category has been granted such relief. In addition, a document with a detailed explanation of the filing is being provided as an attachment.

This transmittal letter and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS). Payment in the amount of \$815.00 has been electronically transmitted to the U.S. Bank in St. Louis, Missouri, in accordance with the fee program procedures.
