Iowa Telecommunications Services, Inc. (Iowa Telecom) hereby submits this filing in order to implement required exogenous cost adjustment due to changes in the Telecommunications Relay Service (TRS) carrier contribution factor and Interstate Telecommunications Service Providers (ITSP) regulatory fee rate. This information is being filed on 15 days notice pursuant to the Federal Communications Commission's ("Commission") streamlined filing procedures and includes adjustments consistent with the requirements of Sections 61.41 through 61.49 of the Commission's Rules.

A proposal to adjust the Universal Service Fund Contribution Charge is included in this filing. In the Commission's September 10, 2010 Public Notice. *In the Matter of Federal-State Joint Board on Universal Service*, CC Docket No. 96-45, Public Notice, DA 10-1716, (rel. September 10, 2010), the Universal Service Fund Surcharge was changed from .136 to .129. This filing proposes to update the Universal Service Fund Recovery Charge to reflect the new percent. The percent is changed from 13.6% to 12.9%.

This filing has been submitted electronically through the Commission's Electronic Tariff Filing System ("ETFS"), in accordance with Section 61.13(b) of the Commission's rules and regulations. 47 C.F.R. § 61.13(b). The appropriate filing fee (\$815.00; fee type code "CQK") is being submitted electronically today, in accordance with Section 61.14(b) of the Commission's rules. 47 C.F.R. § 61.14(b). In addition, the original transmittal letter and the FCC Form 159 (displaying the Electronic Audit Code in the box in the upper left hand corner marked "reserved") are being filed today with the Secretary of the Commission, in accordance Section 61.14(b)(2) of the Commission's rules. 47 C.F.R. § 61.14(b)(2).
