With this filing, NBTC is proposing changes to the DS1 High Capacity Service Portability Commitment option under the DS1 Term Payment Plan. Currently, a Customer is billed an adjustment factor if the Customer's number of in-service Channel Terminations exceeds 124% of the Customer's Commitment Level (CL).

With the proposed changes, a grace period is being established to allow a Customer to increase their CL without being billed the adjustment factor. To qualify for the adjustment factor waiver, a Customer must provide the Telephone Company notice of their CL increase within the calendar month following the reported adjustment, and the CL increase is sufficient that the number of in-service rate elements does not exceed 124% of the new CL.

In accordance with Section 61.14, this transmittal letter and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS) in compliance with the electronic filing procedures.
