#### 7.2 Service Descriptions (Cont'd)

##### 7.2.10 Dry Fiber<sup>1</sup>

(N)

Dry fiber is offered as a point-to-point arrangement between two Customer-designated premises. The Telephone Company will also permit a Customer to provision dry fiber to a collocation arrangement or between two collocation arrangements located in the same central office. If dry fibers are terminated at a collocation arrangement, connecting facility assignments (CFAs) of the fiber cross-connect facility must be provided by the Customer. Additionally, the Customer must: (i) obtain a letter of authorization from the Collocator, and (ii) provide a written copy of the letter of authorization to the Telephone Company if a dispute arises with respect to the authorization for the applicable Services.

This arrangement consists of four optical fibers, where available, and is offered without optical signal regeneration to compensate for signal losses. This service is offered over the Telephone Company fibers "as is" without any modification or re-splicing. The Telephone Company makes no other representations regarding the transmission capability of the facilities. Diverse fiber paths are not provided with this service offering. A fiber cross-connect panel is the only equipment provided for the provision of this service. Fiber cross-connects into collocation arrangements and between collocation arrangements located in the same central office (i.e., Intra-Office Cross Connects) are offered pursuant to the rates and charges provided in Section 13 of this Tariff.

The Customer may utilize the dry fiber for any lawful purpose, however, the Telephone Company does not represent this service as suitable for the Customer's desired applications. The Telephone Company reserves the right to rearrange its network and to modify the manner in which it provides service in order to meet its overall service requirements. This includes, but is not limited to, the right to engineer and construct its fiber optic facilities in accordance with its normal operations without requirement to modify its materials, splicing techniques, or planned facility rearrangements to suit a specific Customer request.

At the request of the Customer, if made prior to the installation of the facilities, the Telephone Company will attempt to estimate the transmission loss of the channel at the Customer's intended transmission wavelength; provided, however, that the Telephone Company does not warrant that the Customer's channel will operate at that estimated loss or that the transmission loss will remain constant during the period in which the Customer obtains the facilities from the Telephone Company.

The Customer must clearly identify facilities termination points at the Customer's premises or at the Customer's collocation arrangements. In addition, the Customer must cooperatively disable any optical transmission equipment on a dry fiber arrangement whenever the Telephone Company must perform maintenance on those facilities.

This arrangement does not provide interconnection to other DS3 and/or DS1 channel services provided by the Telephone Company. No service capabilities are expressed or implied for any such connections by the Customer.
