CenturyLink Operating Companies Tariff F.C.C. Nos. 1 through 10 (CLOC Tariff Nos. 1 through 10) are being filed on not less than one day's notice under authority of Special Permission No. 11-002 of the Federal Communications Commission. On its effective date, these tariffs will cancel CenturyTel Operating Companies Tariff F.C.C. Nos. 1, 2, 3, 4, 5 and 7, Madison River Telephone Company Tariff F.C.C. No. 1, Telephone Utilities Exchange Carrier Association (TUECA) Tariff F.C.C. No. 2 and Embarq Local Operating Companies Tariff F.C.C. Nos. 1 and 2 in their entirety. The regulations, rates and charges contained in CLOC Tariff F.C.C. Nos. 1 through 10 are identical to those found in the current CenturyTel, Madison River, TUECA and Embarq tariffs with the exception of minor textual changes necessary to reflect the revised page numbers and ensure consistent section headings and references.
