With this filing, Verizon is providing for Special Construction of facilities to provision tariffed services in Tariff FCC No. 21 for: MA – Qwest Communications Company LLC, Equipower Resources Corp.; TX – New Cingular Wireless PCS, LLC.

Also with this filing, Verizon is amending the special construction case for Scholastic, Inc. that was filed under Transmittal No. 1069 and became effective on February 5, 2010. This case is being amended to reflect the amendment to the contract due to the customer's request to pay in a single nonrecurring charge, rather than in monthly recurring charges as originally filed. No monthly recurring charges have been paid by the customer and the total cost for the new facilities is not changing.
