5.2.2 Access Order Modifications (Cont'd)

(C) Design Change Charge (Cont'd)

The Telephone Company will review the requested change, notify the customer whether the change is a design change, if it can be accommodated and if a new service date is required. If the customer authorizes the Telephone Company to proceed with the design change, a Design Change Charge will apply. The Design Change Charge will apply on a per order per occurrence basis, for each order requiring a design change. The applicable charge is:

If a change of service date is required, the Service Date Change Charge as set forth in (A) preceding will also apply.

(D) Expedited Order Charge

When placing an Access Order for service(s) for which standard intervals exist, a customer may request a service date that is prior to the standard interval service date.

The customer may also request an earlier service date on a pending standard or negotiated interval Access Order. If the Telephone Company agrees to provide service on an expedited basis, subject to limitations of personnel and material, an Expedited Order Charge will apply.

For DS1 Order, DS3 Order and OC-N Services Expedited intervals, the charge will be per Order as follows: (N)

For services other than DS1, DS3 and OC-N Service, to calculate the additional labor charges, the Telephone Company will, upon authorization from the customer to incur the additional labor charges, keep track of the additional labor hours used to meet the request of the customer and will bill the customer at the applicable Additional Labor charges as set forth in 13.2.6(A) following. (N)

To develop, determine and bill the customer the extraordinary costs which may be involved, the special construction terms and conditions as set forth in CINCINNATI BELL TELEPHONE TARIFF F.C.C. NO. 39 will be used by the Telephone Company. Authorization to incur the costs and to bill the customer will be in accordance with the terms and conditions of CINCINNATI BELL TELEPHONE TARIFF F.C.C. NO. 39.

If the Telephone Company is subsequently unable to meet an agreed upon expedited service date, no Expedited Order Charge will apply unless the missed service date was caused by the customer.

When the request for expediting occurs subsequent to the application date of the Access Order, a Service Date Change Charge as set forth in (A) preceding also applies.

In the event that the customer cancels an expedite request and cancels the circuit order, the Expedite Order Charge will be added to the Cancellation charges set forth 5.2.3 (A) following.
