This filing encompasses a variety of "housekeeping" revisions that JSI is making in order to maintain current Issuing Carrier tables in Section 7, Special Access Service, and Section 16, Public Packet Data Network, as well as minor text corrections to Section 16 regulations and Section 17 rate pages. For your convenience, attached to this transmittal letter you will also find Exhibit 2 which is a summary of the "housekeeping" tariff revisions that JSI is proposing at this time.

Revisions are being proposed on behalf of Farmers Telephone Cooperative, Inc. (SC) in order to reflect the addition of rates for two new Public Packet Data Network Ethernet Transport Service (ETS) speeds, ETS Term Discount offering under existing regulations, as well as the addition of rates and regulations associated with the ETS Virtual Local

Area Network (VLAN) capabilities. The ETS rates proposed for the new speeds under this transmittal as well as the VLAN rates are derived from the introductory ETS rates which became effective on June 4, 2009. A Description and Justification for the new ETS speeds as well as the VLAN service is being provided with this filing. Pursuant to Section 61.38 of the Commission's Rules, supporting cost information related to these services is also attached to this filing as Exhibit 3.

For Knology of the Valley, Inc. (Knology), this filing proposes revision of the Federal Universal Service Charge (FUSC) factor reflective of an increase in the Universal Service Contribution Factor from 14.4% to 15.3% for the fourth quarter of 2011. See Proposed Fourth Quarter 2011 Universal Service Contribution Factor, CC Docket No. 96-45, Public Notice, DA 11-1543 (released September 13, 2011). Knology is not a member of the National Exchange Carrier Association (NECA) Common Line Pool and therefore bills common line charges and related FUSC charges pursuant to JSI Tariff FCC No. 1. All remaining issuing carriers for JSI Tariff FCC No. 1 are members of and participate in the NECA Common Line Pool and reference NECA Tariff FCC No. 5 with respect to FUSC rates.

As the final item, revisions are also being proposed on behalf of Home Telephone Company, Inc. (SC) to reflect a name change due to a corporate reorganization which transferred incumbent local exchange carrier authority and assets to a new entity, Home Telephone ILEC, LLC d/b/a Home Telecom, with the new FRN 0020-9801-16.

Pursuant to Section 61.32(b) of the Commission's Rules, the original of this letter, Form 159, and a check for \$845.00 have been sent via overnight delivery to the U.S. Bank, St. Louis, Missouri, as of this date.
