Dear Ms. Dortch:

Effective December 1, 2011, AT&T Corp. is transferring certain assets and the associated customer base of AT&T Corp. d/b/a AT&T Advanced Solutions to Pacific Bell Telephone Company d/b/a AT&T California. The assets are currently used to provide, among other things, interstate Frame Relay service. Following the transfer of the assets and customer base, Pacific Bell Telephone Company d/b/a AT&T California will replace AT&T Corp. d/b/a AT&T Advanced Solutions as the provider of these services.

Accordingly, the AT&T Operating Companies (ATTOC) propose to revise the AT&T Operating Companies Tariff No. 1 (Advanced Services) to reflect this change in corporate structure by deleting AT&T Corp. from and adding Pacific Bell Telephone Company to the list of Issuing Carriers for this tariff.

ATTOC requests waiver of § 61.58 of the Commission's Rules to make these changes on one day's notice. This waiver is necessary to ensure an effective date of December 1, 2011, which is needed to facilitate the change in the corporate structure.

In accordance with 47 C.F.R. § 61.153, this Application letter and the appropriate illustrative tariff pages are being filed electronically today via the Commission's Electronic Tariff Filing System (ETFS). Payment in the amount of \$845.00 has been electronically transmitted to the US Bank in St. Louis, MO in accordance with the fee program procedures. Form 159 is being transmitted electronically via ETFS. These actions have been committed as the issued (filed) date as reflected above.
