## SECTION 1 - TERMS AND CONDITIONS

### 1.1 Definitions

**Access Line** - A local channel for voice, data, or video communications which connects the Customer location to a location of the Company or its underlying carrier.

**Account** - The Customer who has agreed, orally or in writing, to honor the terms of service established by the Company. An Account may have more than one service billed to the same Customer address. An account may include multiple locations for the same Customer.

**Accounting Code** - A numerical code assigned to the Customer, to enable the Company to complete calls as authorized by the Customer. Multiple Accounting Codes may be assigned to the Customer.

**Aggregator** - Any person, business, firm, entity, etc. that, in the ordinary course of its operations, makes telephones available to the public or to transient users of its premises, for interstate telephone calls using the services of Operator Service Company.

**Authorization Code** - A pre-defined series of numbers to be dialed by the Customer upon access to the Company's system to identify the caller and validate the caller's authorization to use the services provided. The Customer is responsible for charges incurred through the use of his or her assigned Authorization Code.

**Casual Caller** - Any person, firm, corporation or other entity who places calls over the Carrier's network from an Equal Access end office who do not have a current account with the carrier.

**Collect Call** - A billing arrangement whereby the originating caller may bill the charges for a call to the called party, provided the called party agrees to accept the charges.

**SECTION 1 - TERMS AND CONDITIONS, *Cont'd.*****1.1 Definitions, *Cont'd.***

**Credit Card** - A billing convenience whereby the End User may bill charges for a call to an authorized national bank charge card such as VISA, MasterCard or American Express. Terms and conditions of the agreement between the credit card company and its patrons will apply to payment arrangements.

**Company** - Used throughout this tariff to refer to Operator Service Company unless otherwise clearly indicated by the context.

**Customer, Consumer or End User** - Any person, firm, partnership, corporation, or other entity which uses telecommunications services under the provisions and regulations of this tariff and is responsible for payment of charges. The Customer, Consumer or End User is typically a member of the transient public and, as such, does not contract directly with the Company for provisioning or termination of service.

**Customer Dialed Calling Card Call** - A service whereby the End User dials all of the digits necessary to route and bill the call without any operator assistance.

**Debit Account** - An account which consists of a pre-paid usage balance depleted on a real time basis during each Debit Service Call.

**Debit Card** - A card issued by the Company which provides the Customer with a Personal Account Code and instructions for accessing the Carrier's network.

**Debit Service Call** - A service accessed via a "1-800" or other access code dialing sequence whereby the Customer or Authorized User dials all of the digits necessary to route a call. Network usage for each call is deducted from the available usage balance on a Company-issued Debit Account.

**FCC** - Federal Communications Commission

**Holidays** - Holidays observed by the Company are: New Year's Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day.

**Operator-Station Call** - A service whereby caller places a non-Person-to-Person call with the assistance of an operator (live or automated).

**OSC** - Used throughout this tariff to refer to Operator Service Company.

**Person-to-Person Call** - A service whereby the person originating the call specifies a particular person to be reached, or a particular station, room number, department, or office to be reached through a PBX attendant.

**SECTION 1 - TERMS AND CONDITIONS, *Cont'd.*****1.1 Definitions, *Cont'd.***

**Personal Account Code** - A pre-defined series of numbers to be dialed by the Customer or Authorized User upon access to the Carrier's network which identifies the Debit Account from which charges for service shall be debited and which validates the caller's authorization to use the services provided.

**Renewal** - A method of replenishing a Debit Account's Available Usage Balance with additional minutes of use as authorized and paid for by the Customer.

**Telco Card** - A billing convenience whereby the End User may bill the charges for a call to an approved telephone company-issued calling card. The terms and conditions of the local telephone company will apply to payment arrangements. Also referred to as a calling card.

**Third Party Billing** - A billing arrangement by which the charges for a call may be billed to a telephone number that is different from the calling number and the called number.

**Time and Charges** - A service whereby the Company Operator monitors the start and stop time of call and conveys the resulting charges to the calling party or Aggregator for the purposes of on-site payment or call accounting.

## SECTION 2 - RULES AND REGULATIONS

### 2.1 Undertaking of Operator Service Company

OSC's services and equipment are furnished to End Users for communications originating within the United States under terms of this informational tariff. The Company's services and equipment are available twenty-four hours per day, seven days per week.

OSC installs, operates, and maintains the communications services provided in this tariff for End Users in accordance with the terms and conditions set forth under this informational tariff. The Company may act as the Aggregator's agent for ordering access connection facilities provided by carriers or entities, when authorized by the Aggregator, to allow connection of an Aggregator's location to an authorized underlying carrier. The Aggregator shall be responsible for all charges due for such service arrangement.

### 2.2 Limitations

**2.2.1** Service is offered subject to the availability of the necessary facilities and equipment, and is subject to the provisions of this tariff.

**2.2.2** Operator Service Company reserves the right to discontinue or limit service when necessitated by conditions beyond its control, or when the Customer or Aggregator is using service in violation of provisions of this tariff or the law.

**2.2.3** The Company does not undertake to transmit messages, but offers the use of its facilities when available, and will not be liable for errors in transmission or for failure to establish connections.

**SECTION 2 - RULES AND REGULATIONS, *Cont'd.*****2.2 Limitations, *Cont'd.***

**2.2.4** The Company reserves the right to refuse to process Credit Card or Calling Card billed calls when authorization for use of the card cannot be validated or which fail validation.

**2.2.5** The Company reserves the right to discontinue service, limit service, or to impose requirements on Aggregators as required to meet changing regulatory or statutory rules and standards, or when such rules and standards have an adverse material effect on the business or economic feasibility of providing service, as determined by OSC in its reasonable judgment.

**2.3 Assignment or Transfer**

All services provided under this tariff are directly or indirectly controlled by OSC and neither the Aggregator nor Customer may transfer or assign the use of service or facilities without the express written consent of the Company. Such transfer or assignment shall only apply where there is no interruption of the use or location of the service or facilities.

Prior written permission from the Company is required before any assignment or transfer. All regulations and conditions contained in this tariff shall apply to all such permitted assignees or transferees, as well as all conditions of service.

**2.4 Use**

Services provided under this tariff may be used for any lawful purpose for which the service is technically suited.

**SECTION 2 - RULES AND REGULATIONS, *Cont'd.*****2.5 Liabilities of the Company**

- 2.5.1** Operator Service Company's liability for damages arising out of mistakes, interruptions, omissions, delays, errors, or defects in transmission which occur in the course of furnishing service or facilities, in no event shall exceed an amount equivalent to the proportionate charge for the period during which the faults in transmission occur.
- 2.5.2** The Company shall not be liable for claim or loss, expense or damage (including indirect, special or consequential damage), for any interruption, delay, error, omission, or defect in any service, facility or transmission provided under this tariff, if caused by any person or entity other than the Company, by any malfunction of any service or facility provided by any carrier, by an act of God, fire, war, civil disturbance, or act of government, or by any other cause beyond the Company's direct control.
- 2.5.3** The Company shall not be liable for, and shall be fully indemnified and held harmless by Customer and Aggregator against any claim or loss, expense, or damage (including indirect, special or consequential damage) for defamation, libel, slander, invasion, infringement of copy-right or patent, unauthorized use of any trademark, trade name or service mark, unfair competition, interference with or misappropriation or violation of any contract, proprietary or creative right, or any other injury to any person, property or entity arising out of the material, data, information, or other content revealed to, transmitted, or used by the

Company under this tariff; or for any act or omission of the Customer or Aggregator; or for any personal injury or death of any person caused directly or indirectly by the installation, maintenance, location, condition, operation, failure, presence, use or removal of equipment or wiring provided by the Company, if not directly caused by negligence of the Company.

**2.5.4** The Company shall not be liable for any defacement of or damages to the premises of an Aggregator resulting from the furnishing of service which is not the direct result of the Company's negligence.

**2.5.5** The Company may not limit liability for willful misconduct.

**2.6 Deposits**

The Company does not require a deposit from the Customer.

**2.7 Taxes and Fees**

**2.7.1** All state and local taxes (i.e., gross receipts tax, sales tax, municipal utilities tax) are listed as separate line items on the Customer's bill and are not included in the quoted rates and charges set forth in this tariff.

**2.7.2** To the extent that a municipality, other political subdivision or local agency of government, or Commission imposes upon and collects from the Company a gross receipts tax, occupation tax, license tax, permit fee, franchise fee, or regulatory fee, such taxes and fees shall, insofar as practicable and allowed by law, be billed pro rata to Customers receiving service from the Company within the territorial limits of such municipality, other political subdivision or local agency of government.

**SECTION 2 - RULES AND REGULATIONS, *Cont'd.*****2.7 Taxes and Fees, *Cont'd.***

**2.7.3** The Company may adjust its rates and charges or impose additional rates and charges on its Customers in order to recover amounts it is required by governmental or quasi-governmental authorities to collect from or pay to others in support of statutory or regulatory programs. Examples of such programs include, but are not limited to, the Universal Service Fund (USF). Imposition, billing and collection of such rates and charges are subject to billing and other system changes by the Company.

- A. For recovery of contributions paid by the Company to support Universal Service Fund Fee (USF)

Telecommunications services provided by the Company are subject to an undiscountable monthly Universal Service Fund Fee, payable by the Customer. The fee shall be a percentage, as dictated and adjusted periodically by the FCC, of the gross amounts exclusive of taxes attributable to interstate and international services billed to the Customer by the Company.

The USF Fee will not be applied to services sold by the Company to a Customer for resale for which the Customer has filed a Universal Service Worksheet, unless the Customer has a de minimis exemption which exempts the Customer from paying directly into the Universal Service Fund. These percentages will be subject to periodic adjustment by the Company. State USF charges will be applied to gross call amounts (exclusive of taxes) when required by State agencies.

**SECTION 2 - RULES AND REGULATIONS, *Cont'd.*****2.7 Taxes and Fees, *Cont'd.*****2.7.3 *Cont'd.*****B. Presubscribed Interexchange Carrier Charge**

For any telephone line, automatic number identification (ANI), terminal, extension, or equivalent for which the Company is designated by the Local Exchange Carrier, cellular service provider, personal communications service provider, or other similar entity to be a Customer's Primary Interexchange Carrier (PIC), the Company will assess the Customer a monthly recurring charge, called a Presubscribed Interexchange Carrier Charge (PICC), for each line or equivalent, that the Company is so designated. The aggregate of these PICCs will not be prorated for a partial month of service, are not subject to any discounting and do not contribute to any monthly minimums. The PICCs charged by the Company are as follows:

**SECTION 2 - RULES AND REGULATIONS, *Cont'd.*****2.8 Obligations of the Aggregator**

When service is provided to the transient public through an Aggregator, the Aggregator must post on or near the telephone instrument in plain view of Consumers:

- (A) name, address and toll-free telephone number of Operator Service Company;
- (B) a written disclosure that the rates for all operator-assisted calls are available on request, and that Consumers have a right to obtain access to the interstate common carrier of their choice and may contact their preferred interstate common carriers for information on accessing that carrier's service using that telephone; and
- (C) the name and address of the enforcement division of the Common Carrier Bureau of the FCC, to which the Consumer may direct complaints regarding operator services.

Aggregators must ensure that each of its telephones presubscribed to Operator Service Company allows the Consumer to use "800," "950," and 10XXX (where feasible) access code numbers to obtain access to the provider of operator services desired by the Consumer.

No charge by the Aggregator to the Consumer for using an "800" or "950" access code number, or any other access code number, may be greater than the amount the aggregator charges for calls placed using the presubscribed provider of operator services (Operator Service Company.)

Aggregators must comply with any access requirements or rules that the FCC sets forth.

**SECTION 2 - RULES AND REGULATIONS, *Cont'd.*****2.9 Interconnection with Aggregator**

The Company's facilities and service may be used with or terminated in Aggregator-provided terminal equipment or Aggregator-provided communications systems, such as a telephone set, PBX, pay phone or key system. Such terminal equipment shall be furnished and maintained at the expense of the Aggregator, except as otherwise provided. The Aggregator is responsible for all costs at his or her premises, including personnel, wiring, electrical power, and the like, incurred in the use of the Company's service. When such terminal equipment is used, the equipment shall comply with the generally accepted minimum protective criteria standards of the telecommunications industry as endorsed by the Federal Communications Commission.

**2.10 Installation and Termination**

Service is installed upon mutual agreement between the Aggregator and the Company. The service agreement does not alter rates specified in this tariff.

**SECTION 2 - RULES AND REGULATIONS, *Cont'd.*****2.11 Payment for Service**

The Customer is responsible for payment of all charges for services and equipment furnished to the Customer or to an authorized End User of the Customer by Operator Service Company. All charges due by the Customer are payable to the Company or to the Company's authorized billing agent (such as a local exchange telephone company).

Any objections to billed charges must be reported to the Company or its billing agent within sixty days after receipt of bill. Adjustments to Customer's bills shall be made to the extent that circumstances exist which reasonably indicate that such changes are appropriate.

**2.12 Interconnection with Carriers**

Service furnished by Operator Service Company may be connected with the services or facilities of carriers or other companies. Such service or facilities, if used, are provided under the terms, rates and conditions of the other carrier or company. The Aggregator is responsible for all charges billed by carriers for use in connection with OSC's service. Any special interface equipment or facilities necessary to achieve compatibility between carriers is the responsibility of the Aggregator.

**SECTION 2 - RULES AND REGULATIONS, *continued*****2.13 Refusal or Discontinuance by Company**

Operator Service Company may refuse or discontinue service under the following conditions. Unless otherwise stated, the Customer or Aggregator will be given notice and allowed a reasonable time to comply with any rule or remedy any deficiency.

- (A) For non-compliance with and/or violation of any Federal, State or municipal law, ordinance or regulation pertaining to telephone service.
- (B) For the use of telephone service for any other property or purpose other than that described in the application.
- (C) For neglect or refusal to provide reasonable access to the Company for the purpose of inspection and maintenance of equipment owned by the Company.
- (D) For noncompliance with and/or violation of the FCC's regulations or the Company's rules and regulations.
- (E) For non-payment of bills for telephone service.
- (F) Without notice in the event of Customer or Aggregator use of equipment in such a manner as to adversely affect the Company's equipment or the Company's service to others.
- (G) Without notice in the event of tampering with the equipment furnished and owned by the Company.

**SECTION 2 - RULES AND REGULATIONS, *continued*****2.13 Refusal or Discontinuance by Company, *Cont'd.***

- (H) Without notice in the event of unauthorized or fraudulent use of service. Whenever service is discontinued for fraudulent use of service, the Company may, before restoring service, require the Customer or Aggregator to make, at his own expense, all changes in facilities or equipment necessary to eliminate illegal use and to pay an amount reasonably estimated as the loss in revenues resulting from such fraudulent use.
- (I) For failure of the Aggregator to make proper application for service.
- (J) For Aggregator's breach of the contract for service between the Company and the Aggregator.
- (K) When necessary for the Company to comply with any order or request of any governmental authority having jurisdiction.

**2.14 Inspection, Testing and Adjustment**

Upon reasonable notice, the services provided by the Company shall be made available to the Company for tests and adjustments as may be deemed necessary by the Company for maintenance. No interruption allowance will be granted for the time during which such tests and adjustments are made when the interruption is less than twenty-four consecutive hours.

**SECTION 2 - RULES AND REGULATIONS, *continued*****2.15 Interruption of Service**

Credit allowances for interruptions of service which are not due to the Company's testing or adjusting, to the negligence of the Customer or Aggregator, or to the failure of channels, equipment or communications systems provided by the Aggregator, are subject to the general liability provisions set forth in Section 1.2.5 herein. It shall be the obligation of the Customer or Aggregator to notify Company immediately of any interruption in service for which a credit allowance is desired by Customer or Aggregator. Before giving such notice, Aggregator shall ascertain that the trouble is not within his or her control, or is not in wiring or equipment, if any, furnished by Aggregator and connected to Company's terminal. Interruptions caused by Aggregator-provided or Company-provided automatic dialing equipment are not deemed an interruption of service as defined herein since the Customer has the option of using the long distance network via local exchange company access.

**2.16 Other Rules**

**2.16.1** The Company reserves the right to discontinue service, limit service, or to impose requirements on Customers as required to meet changing regulatory rules and standards of the Federal Communications Commission.

**2.16.2** The Company shall not be liable for any claim, loss, or refund as a result of loss or theft of Personal Account Codes issued for use with the Company's services.

**2.17 Miscellaneous Rates and Charges**

The Company may adjust its rates and charges or impose additional rates and charges on its Customers in order to recover amounts it is required by governmental or quasi-governmental authorities to collect from or pay to others in support of statutory or regulatory programs. Example of such programs include, but are not limited to, the Universal Service Fund, the Primary Interexchange Carrier Charge, and compensation to payphone service providers for the use of their payphones to access the Company's service.

**SECTION 3 - SERVICE AND RATE DESCRIPTION, *continued*****3.4 Calculation of Distance**

Mileage measurements for rate schedules are based on the distance in airline miles between wire centers associated with the originating and terminating stations.

The distance between the originating and terminating points is calculated by using the industry standard "V" and "H" coordinates of the serving wire centers.

**Step 1:** Obtain the "V" and "H" coordinates for the serving wire center serving the Customer's location and the called/calling station.

**Step 2:** Obtain the difference between the "V" coordinates. Obtain the difference between the "H" coordinates.

**Step 3:** Square the differences obtained in Step 2.

**Step 4:** Add the squares of the "V" difference and "H" difference obtained in Step 3.

**Step 5:** Divide the sum of the square obtained in Step 4 by ten (10). Round to the next higher whole number if any fraction results from the division.

**Step 6:** Obtain the square root of the whole number obtained in Step 5. Round to the next higher whole number if any fraction is obtained. This is the distance between the originating and terminating locations of the call.

In order to recover the Company's expenses to comply with the FCC's pay telephone compensation plan effective on October 7, 1997 (FCC 97-371), an undiscountable per call charge is applicable to all interstate, intrastate and international calls that originate from any domestic pay telephone used to access the Company's services. This surcharge, which is in addition to standard tariffed usage charges and any applicable service charges and surcharges associated with the Company's service, applies for the use of the instrument used to access the Company service and is unrelated to the Company's service accessed from the pay telephone.

Pay telephones include coin-operated and coinless phones owned by local telephone companies, independent companies and other interexchange carriers. The Pay Telephone Surcharge applies to the initial completed call and any reoriginated call (i.e., using the "#" symbol).

Whenever possible, the Pay Telephone Surcharge will appear on the same invoice containing the usage charges for the surcharged call. In cases where proper pay telephone coding digits are not transmitted to the Company prior to completion of a call, the Public Pay Telephone Surcharge may be billed on a subsequent invoice after the Company has obtained information from a carrier that the originating station is an eligible pay telephone.

The Pay Telephone Surcharge does not apply to calls placed from pay telephones at which the Customer pays for service by inserting coins during the progress of the call.

Operator Assisted Calling Services allow Customers to place calls using operator assistance for call completion or billing. The Company offers operator assisted ("0+") calling for specialized billing or call placement arrangements. When service is billed through another entity (i.e. the local exchange company) the terms of the billing entity apply. The following payment options are available to end users of OSC, Inc.'s service:

- A. Collect Calls - This option allows a call to be billed to the called number, provided that the called station accepts responsibility for payment of charges.
- B. Calling Card Calls - This option enables an end user to charge a call to a valid telephone company calling card.
- C. Credit Card Calls - This option enables an end user to charge a call to a valid major credit card (i.e. MasterCard, Visa, American Express, Discover, etc.).
- D. Originating Number Billing - This option allows the end user to bill a call to the calling telephone number. End user accepts responsibility for payment of charges. Originating Number Billing may not be accepted from pay telephones and other restricted telephone numbers. All direct dial calls are billed to the originating line.

Usage charges and an appropriate service charge will be assessed on a per call basis. For calls made using a telephone company card, acceptance of the card will be dependent upon the Company's ability to verify the card as valid. Only those cards accepted by the Company may be used for Operator Services. The Company reserves the right to verify acceptance of charge prior to billing charges to a third party number.

The Company reserves the right to verify that the alternative offering is an approved tariff on file with the Commission.

**5.2.2 Best Rate Guarantee Promotion**

OSC will, at its discretion, match certain standard non-promotional offerings of other interexchange carriers or resellers in order to retain existing accounts. The competing rate must be provided in writing and be listed in an approved tariff on file with the Commission and must result in a lower overall bill for the same service offered by the Company.
