This application is hereby made by Nevada Bell Telephone Company (NBTC) for Special Permission to waive Section 61.74 of the Commission's Rules in order to make references in NBTC Tariff F.C.C. No. 1, Access Service Offer, Contract Offer No. XX, to the similar contract tariffs of the following AT&T Telephone Companies: Pacific Bell Telephone Company (PBTC) Tariff F.C.C. No. 1, Contract Offer No. YYY; and Southwestern Bell Telephone Company (SWBT) Tariff F.C.C. No. 73 Contract Offer No. ZZZ.

NBTC is proposing to offer a Special Access Service Offer (Contract Offer No. XX), a Minimum Annual Revenue Commitment (MARC) plan for which concurrent subscription is required to this Contract Offer and the following Access Tariffs: Pacific Bell Telephone Company (PBTC) Tariff F.C.C. No. 1, Contract Offer No. YYY and Southwestern Bell Telephone Company (SWBT) Tariff F.C.C. No. 73, Contract Offer No. ZZZ (collectively, with this Contract Offer No. XX, referred to as "Concurrently Subscribed Contract Offers." PBTC, SWBT, together with the Telephone Company, shall be identified herein as the "Qualified Companies. An application to waive Section 61.74 of the Commission's Rules is also being requested by PBTC and SWBT in separate filings.

In accordance with Section 61.14, this application letter and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS) in compliance with the electronic filing procedures.
