The accompanying tariff material issued by John Staurulakis, Inc. (JSI), and bearing Tariff F.C.C. No. 1, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended.

The F.C.C. Registration Number (FRN) for JSI is 0003-7481-42. The FRNs for the issuing carriers for JSI Tariff F.C.C. No. 1 are provided at Exhibit 1 to this transmittal letter.

The filing, to become effective January 1, 2012, consists of tariff pages as indicated on the following checksheet:

On behalf of Tri County Telephone Association, Inc., ("Tri County") JSI proposes to add Tri County as an Issuing Carrier of JSI Tariff FCC No. 1, effective January 1, 2012, concurrent with the cancellation of Tri County Interstate Access Tariff FCC No. 1, also effective January 1, 2012. This filing to add Tri County as an Issuing Carrier to JSI Tariff FCC No. 1 does not change any of Tri County's existing interstate access rates. All rates charged by Tri County under JSI Tariff FCC No. 1 effective January 1, 2012 will be the same rates as those rates currently charged under Tri County Tariff FCC No. 1. Additionally, all services currently offered under Tri County Tariff FCC No. 1 will be offered by Tri County under JSI Tariff FCC No. 1. Lastly, no new services with respect to those offered by Tri County will be introduced in this filing. Tri County files under

Section 61.39 of the Commission's Rules. A Description and Justification is provided with tariff comparisons as Exhibits 1 and 2.

Pursuant to Section 61.87(a), JSI is including with this Transmittal the revised Title Page for Tri County Tariff FCC No. 1 with the required indication that the tariff is no longer effective.

Revisions are also being proposed on behalf of the TDS Telecom Companies, Inc. (TDS Telecom) in order to reflect the addition of four new Public Packet Data Network Ethernet Transport Service (ETS) speeds in JSI Tariff F.C.C. No. 1. JSI is also proposing to add a new ETS Fixed Rate Option Plan to mirror the ETS Fixed Rate Option Plan found in the National Exchange Carrier Association ("NECA") Tariff F.C.C. No. 5. Lastly, Term Discount and Volume Discount Plans have been added to TDS Telecom's ETS service offering. A Description and Justification addressing the new ETS speeds as well as the Fixed Rate Option Plan, Term Discount Plan and Volume Discount Plan is being provided with this filing. Pursuant to Section 61.38 of the Commission's Rules, supporting cost information and rate design information related to these services is also attached to this filing as Exhibits 1 and 2 of the Description and Justification.

Additionally, JSI is adding regulations necessary to add Glide Path Language for Replacement Services on Discount Plans to Section 7 of the JSI Tariff FCC No. 1 as well as other minor tariff revisions on behalf of TDS Telecom.

For Knology of the Valley, Inc. (Knology), this filing proposes revision of the Federal Universal Service Charge (FUSC) factor reflective of an increase in the Universal Service Contribution Factor from 15.3% to 17.9% for the first quarter of 2012. See Proposed First Quarter 2012 Universal Service Contribution Factor, CC Docket No. 96-45, Public Notice, DA 11-2020 (released December 14, 2011). Knology is not a member of the National Exchange Carrier Association (NECA) Common Line Pool and therefore bills common line charges and related FUSC charges pursuant to JSI Tariff FCC No. 1. All remaining issuing carriers for JSI Tariff FCC No. 1 are members of and participate in the NECA Common Line Pool and reference NECA Tariff FCC No. 5 with respect to FUSC rates.

As the final item, this filing encompasses a variety of "housekeeping" revisions that JSI is making in order to add regulations to Section 5, Access Ordering, maintain current Issuing Carrier tables in Section 7, Special Access Service, and Section 16, Public Packet Data Network, as well as minor text corrections to Section 16 regulations and Section 17 rate pages. For your convenience, attached to this transmittal letter you will also find Exhibit 2 which is a summary of the "housekeeping" tariff revisions that JSI is proposing at this time.

Pursuant to Section 61.32(b) of the Commission's Rules, the original of this letter, Form 159, and a check for \$845.00 have been sent via overnight delivery to the U.S. Bank, St. Louis, Missouri, as of this date.
