APPLICATION OF TARIFF

This Tariff contains the rates, terms and conditions of use applicable to interstate and international resale telecommunications services provided by Americatel to business and residential customers. The Tariff applies only to Dial-Around Services, but only until the Customer has entered into a Service Agreement with Americatel or until forty-five (45) days after service has been established. Americatel's Services are furnished subject to the availability of facilities and subject to the terms and conditions of this Tariff. Americatel is authorized to provide service by the Federal Communications Commission under File Nos. ITC-T/C-20010119-00047; ITC-214-19970312-00146; ITC-214-19970421-00220; ITC-96-263; ITC-94-514; ITC-94-321; ITC-93-160-TC; ITC-92-166, and ITC-92-165.

Americatel's Services are not part of a joint undertaking with any other entity providing telecommunications channels, facilities or services, but involve the resale of the facilities and/or services of underlying carriers.

The rates and regulations contained in this Tariff apply only to the Services furnished by Americatel and do not apply, unless otherwise specified, to the lines, facilities, or services provided by a local exchange telephone company or other common carrier for use in accessing the services of Americatel.

SECTION 1 - DEFINITIONS

Americatel - Americatel Corporation d/b/a 10 123 Americatel d/b/a 1010 123 Americatel d/b/a Ametex, d/b/a Startec, d/b/a 1010-719, d/b/a 101-6868, 433 E. Las Colinas Boulevard, Suite 400, Irving, Texas 75039, a corporation organized under the laws of the State of Delaware.

Additional Period - The rate element used to bill chargeable time when a call continues beyond the Initial Period. The Additional Period starts when the Initial Period ends. Additional Period rates apply to any fraction of the time period for chargeable time beyond the Initial Period. Additional Periods vary by rate schedule and are specified in each individual rate table contained in later sections of this Tariff.

Authorized User - A natural person or legal entity which is authorized by the Customer to use the Company's Service under the terms and regulations of this Tariff.

CAC - An interexchange carrier access code.

Casual Calling - Access to the Company's network and the subsequent use of Service by an End User Customer who does not have a current account with the Company. Access is obtained by dialing the numbers of any of these codes: 1010123, 1016868 or 1010719 before the telephone number that the Customer wishes to call.

Cellular - Refers to the per-minute rate for calls terminating in the specified country.

Connecting Location - The location at which a customer-provided communications channel interconnects with Americatel's facilities for transmission of communications to a carrier earth station at an originating or terminating location.

Customer - A person, firm, partnership, corporation or other entity who places dial-around calls using one of the Company's CACs (1010123, 1015688, 1010719 or 1016868) or whose telephone equipment is used to place such calls and who thus is responsible for payment of the charges and compliance with the provisions of this Tariff. A call can be placed by a person, firm, partnership, corporation or other entity without originating from such entity.

SECTION 1 – DEFINITIONS, (CONT'D.)

Customer Premises - Premises under the ownership or control of Customer or User.

Customer-Provided Communications Channel - A communications channel, which is owned, installed, operated and maintained by the customer or acquired by the customer from a private system or any Other Facilities Supplier, and which is established between the customer premises and a connecting location.

Customer-Provided Equipment - Facilities and equipment including wiring supplied by the customer at terminal locations or on Customer Premises in connection with the service.

Customer Service Order - A standard order form that requests information pertaining to billing, technical and other descriptive information designed to enable Americatel to provide service to the customer.

Day - From 7:00 AM up to, but not including, 8:00 PM local time Monday through Friday.

Dial-Around Service - Calls placed by dialing Americatel's customer access codes, 10-10-123, 1015688, 1010-719 and 101-6868, plus the called party's telephone number.

Evening/Night/Weekend - From 8:00 PM up to, but not including, 7:00 AM local time Monday through Friday, and 24 hours a day on Saturday, Sundays and Holidays.

Holidays - Americatel's recognized holidays are New Year's Day (January 1), Memorial Day, Independence Day (July 4), Labor Day, Thanksgiving Day and Christmas Day (December 25).

Initial Period - The initial period is the length of call for minimum billing purposes. The initial periods vary by rate schedule and are specified in each individual rate table contained in other sections of this Tariff.

SECTION 1 – DEFINITIONS, (CONT'D.)

IXC - Interexchange Carrier.

LATA - A geographic area existing on February 8, 1996, as previously established by the U.S. District Court for the District of Columbia in Civil Action No. 82-0192, or established by a Bell operating company after February 8, 1996, and approved by the FCC.

LEC - Local Exchange Carrier.

Mainland United States - The forty-eight (48) states within the continental United States of America and the District of Columbia.

SECTION 1 – DEFINITIONS, (CONT'D.)

Other Facilities Supplier - An entity other than Americatel with which a Customer or any User, or Americatel as a designated agent, makes arrangements to acquire facilities or services in connection with the Services furnished by Americatel pursuant to this Tariff.

PBX - Private Branch Exchange.

Residential Customer - For the purposes of this Tariff, a Residential Customer is a Customer of the Company whose primary use of the Company's Service is for personal use in a house, apartment or other residential dwelling unit. A Residential Customer is also a Customer who accesses the Company's Service using a presubscribed Access Line that has been assigned a residential class of service by the local service provider.

Service - Non-presubscribed outbound only causal calling service to residential and business customers. All Company services are available 24 hours a day, seven days a week. This service is used by dialing one of the Company's carrier access codes followed by the destination number.

SECTION 1 – DEFINITIONS, (CONT'D.)

Service Agreement - An agreement between Americatel and the Customer that governs the rates, terms, and conditions under which Americatel provides and the Customer purchases service. A Service Agreement may be in printed or electronic, or implied from the Customer's use of a Service after receiving information about the Service, and its rates, terms, and conditions.

Startec - Refers to the 1010-719 and 101-6868 services marketed under the Startec brand.

Underlying Carrier - A facilities-based interexchange carrier or reseller providing Services that are resold by Americatel.

United States or U.S. - The area within the boundaries of the 50 states, the District of Columbia, and any U.S. territories or possessions, as defined by federal statutes.

User - See "Customer" above.

Wireless Termination Surcharge - An additional charge imposed on a per-minute basis, to recover any additional costs incurred by Americatel for the termination of a Customer's call to a wireless subscriber, telephone, or device, when such termination results in a charge to Americatel that is above the charges incurred by Americatel for the termination of a comparable call to a wireline customer, telephone, or device.

SECTION 2 - REGULATIONS

2.1 Undertakings of Americatel

- 2.1.1 Notwithstanding the mention of certain Services in this Tariff, Americatel will provide pursuant to this Tariff only those Services for which rates are specified in dollar amounts in this Tariff.

Service is offered to Residential and Business Customers of the Company to provide casual calling interstate long distance calls between locations within the United States and between the United States and international destinations.

The Company does not undertake to transmit messages but furnishes the use of its facilities to its Customers for communications. All Services are provided subject to the terms and conditions set forth in this Tariff. In the event of a conflict between a contract entered into by the Company and this Tariff, the terms of this Tariff shall prevail.

- 2.1.2 Americatel's Services and facilities are furnished for communications originating and/or terminating at specified points within the United States under the terms of this Tariff and are provided herein in accordance with the terms and conditions set forth under this Tariff. Americatel may act as the Customer's agent for ordering access connection facilities provided by other carriers or entities when authorized by Americatel, to allow connection of a Customer's location to Americatel's network. The Customer shall be responsible for all charges due to such service arrangement.

- 2.1.3 Americatel shall be responsible only for the resale of the Services it offers.

- 2.1.4 Americatel's Services are available twenty-four hours per day, seven days per week.

SECTION 2 - REGULATIONS, (CONT'D.)

2.2 Additional Services

In the event that Americatel, in order to meet the requirements of a customer, is required to construct new facilities or to make special arrangements with respect to its facilities, the applicable charges will be based on Americatel's costs, on a case-by-case basis. These charges may be based on such cost elements as: cost of equipment and materials, cost of installation, engineering, labor, supervision, shipping and transportation, general and administrative overhead, interest during construction, other disbursements, depreciation, maintenance, taxes, provision for return on investment, and any other costs associated with the provision of the special services to be provided.

SECTION 2 - REGULATIONS, (CONT'D.)

2.3 Limitations on Provision of Service

2.3.1 All Service is offered subject to availability of the necessary facilities of Americatel or of underlying carriers, to the provisions of this Tariff, and to applicable law.

2.3.2 Except as indicated otherwise herein, Americatel reserves the right to refuse, block or discontinue Service immediately and without prior notice, to Customers without incurring liability for damages due to the loss of telephone service:

For non-payment of any sum owing to Americatel;

Americatel determines that a Customer is a credit risk;

Customer refuses to pay a deposit or adhere to a credit limit to reduce Customer's credit risk;

For insufficient or fraudulent billing information, invalid or unauthorized telephone numbers, credit card numbers or pre-arranged account code numbers;

For any violation by a Customer of either the provisions of this Tariff or any applicable laws, rules, regulations, or policies of any governmental authority, if such violation is related to any request for Service;

By reason of any order or decision of a court or other governmental authority which prohibits Americatel from furnishing such Service;

If Americatel deems such refusal necessary to protect itself or third parties against fraud, abuse of the service or otherwise to protect its personnel, agents, or Services;

If such refusal, blocking, or discontinuance otherwise is made necessary by conditions beyond Americatel's control.

SECTION 2 - REGULATIONS, (CONT'D.)

2.3 Limitations on Provision of Service, (Cont'd.)

2.3.2 (Cont'd.)

Americatel has received notice from the Customer's local telephone company that the local telephone company has cancelled the Customer's local exchange service;

Customer has acted in a manner that is threatening, obscene, harassing, or abusive to Americatel personnel;

Customer's telephone equipment fails to pass back to Americatel the appropriate signal to start and stop billing for a call;

Customer's local exchange carrier will not place the charges for the Service on the Customer's local exchange carrier invoice;

Customer's phone system is being used by third-parties without the Customer's authorization to place telephone calls.

The discount of the Services by Americatel does not relive Customer of any obligation to pay Americatel for charges due and owing for Services furnished up to the time of discontinuance.

SECTION 2 - REGULATIONS, (CONT'D.)

2.3 Limitations on Provision of Service, (Cont'd.)

- 2.3.3 Service may be discontinued by Americatel, at any time and without notice to its Customers, by blocking traffic to or from certain countries, cities, NXX codes, or individual telephone stations, by blocking call origination for Americatel services, or by blocking calls using certain customer authorization codes and/or access codes, when Americatel deems it necessary to take such action to prevent unlawful and/or unauthorized use of its services.

In addition and without any prior notice, Americatel may refuse, block or discontinue service to any Customer who changes local telephone service providers unless and until Americatel receives new and accurate billing name and address information for such Customer.

- 2.3.3 The Customer may not transfer or assign its rights or duties under this Tariff without the express written consent of Americatel. All regulations and conditions contained in this Tariff shall apply to all such assignees or transferees that Americatel has authorized.

SECTION 2 - REGULATIONS, (CONT'D.)

2.4 Limitation of Americatel's Liability

- 2.5.1 Except as stated in this Subsection, Americatel shall have no liability for damages of any kind arising out of or related to events, acts, rights, obligations, or privileges contemplated by this Tariff. This Tariff does not limit the liability of Americatel for willful misconduct.
- 2.5.2 The liability of Americatel to its Customer(s) resulting in whole or in part from, or arising in connection with, the furnishing of Service under this Tariff, including, but not limited to, mistakes, omissions, interruptions, delays, errors or other defects or misrepresentations, shall not exceed an amount equal to the lesser of \$500 or the charge applicable under this Tariff to the call or calls affected. No other liability in any event shall attach to Americatel, including liability resulting from the unavailability of Service due to the failure or inoperability of any Customer-Provided Equipment.
- 2.5.3 Americatel shall not be liable for any failure of performance hereunder due to causes beyond its control, including, but not limited to: Acts of God, fires, flood or other catastrophes; any law, order, regulation, directive, action or request of the United States Government, or any other government, including state and local governments having jurisdiction over Americatel, or of any department, agency, commission, bureau, corporation or other instrumentality of any one or more of said governments, or of any civil or military authority; national emergencies, insurrections, riots, wars or labor difficulties.
- 2.4.4 Americatel shall not be liable for any claim or loss, expense or damage arising out of the provision of Service (including direct, special or consequential damages, attorney fees or court costs), or for any interruption, delay, error, omission, or defect in any Service, facility or transmission provided under this Tariff, if caused by any person or entity other than Americatel.

SECTION 2 - REGULATIONS, (CONT'D.)

2.4 Limitation of Americatel's Liability, (Cont'd.)

- 2.4.5 Americatel will not be liable for punitive, reliance, or special damages (unless an applicable statute expressly authorizes such damages), and Americatel will not be liable for indirect or consequential damages, including but not limited to lost profits or revenue or increased costs of operation. These limitations apply even if the damages were foreseeable or Americatel was told they were possible, and they apply to any type of claim that does not involve willful misconduct, no matter how that claim is styled or on what legal grounds (such as contract, tort, statute, misrepresentation) it is based.
- 2.4.6 The Customer agrees that Startec should not be responsible for any third-party claims against Americatel that arise from his/her use of the Services. Further, the Customer agrees to reimburse Startec for all costs and expenses related to the defense of any such claims, including attorneys' fees, unless such claims are based on Americatel's willful misconduct or gross negligence.
- 2.4.7 The Customer shall defend, indemnify and save harmless Americatel from and against any suits, claims, losses or damage, including punitive damages, attorney fees and court costs, brought or caused by the Customer or third parties and arising out of any act or omission of the Customer in the course of any authorized use, unauthorized use or misuse of Americatel's Services, or the Customer's equipment or facilities. Unauthorized use or misuse of the Customer's equipment or facilities includes, but is not limited to, the unauthorized use or misuse of such equipment or facilities by the Customer's agent(s) or other third parties. Americatel does not warrant or guarantee that it can prevent such unauthorized use or misuse, and the Customer is responsible for controlling access to, and use of, its own equipment and facilities.

SECTION 2 - REGULATIONS, (CONT'D.)

2.4 Limitation of Americatel's Liability, (Cont'd.)

- 2.4.8 Americatel shall not be liable for, and shall be fully indemnified and held harmless by the Customer against, any claim or loss, expense or damage (including indirect, special or consequential damages, attorney fees or court costs) for defamation, libel, slander, invasion of privacy, infringement of copyright or patent, unauthorized use of any trademark, tradename or service mark, unfair competition, interference with or misappropriation or violation of any contract, proprietary or creative right, or any other injury or harm to any person, property or entity arising out of the material, data, information, or other content revealed to, transmitted, or used by Americatel under this Tariff; or for any act or omission of the Customer.
- 2.4.9 AMERICATEL MAKES NO WARRANTY, EITHER EXPRESS OR IMPLIED, CONCERNING THE SERVICES, INCLUDING, WITHOUT LIMITATION, WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
- 2.5.10 No agent or employee of any other carrier shall be deemed to be an agent or employee of Americatel unless Americatel or a duly authorized agent or employee of Americatel so authorizes in writing.

SECTION 2 - REGULATIONS, (CONT'D.)

2.5 Provision of Equipment

2.5.1 Customer-Provided Equipment at the Customer's Premises for use in connection with Services provided hereunder shall be so constructed, maintained and operated as to work satisfactorily with the Services and facilities of Americatel, and/or Americatel's Underlying Carriers. Such Customer-Provided Equipment shall be in compliance with all applicable rules and regulations of the Federal Communications Commission and the requirements of the Communications Act of 1934, as amended.

2.5.2 Americatel shall not be responsible for the installation, operation or maintenance of any Customer-Provided Equipment. Where such equipment is connected to Services furnished pursuant to this Tariff, the responsibility of Americatel shall be limited to the furnishing of Services under this Tariff in the proper manner. Subject to this requirement, Americatel shall not be responsible for:

the through transmission of signals generated by Customer-Provided Equipment or for the quality of, or defects in, such transmission;

the reception of signals by Customer-Provided Equipment; or

network control signaling where such signaling is performed by Customer-Provided network control signaling equipment.

SECTION 2 - REGULATIONS, (CONT'D.)

2.6 Payment for Services

- 2.6.1 The Customer is responsible for the payment of all charges for Services furnished to the Customer and Customer's employees, tenants, invitees, members of the Customer's household agent(s) or patrons of the Customer, and for all calls placed by or through Customer's equipment directly or via any remote access features. The Customer is also responsible for the payment of charges for calls originated at the Customer's numbers which are not collect, third party, calling card or credit card calls.

In particular and without limitation to the foregoing, the Customer is responsible for any and all charges incurred as the result of:

- A. any delegation of authority resulting in the use of the Customer's or its Authorized User's communications equipment and/or network services which result in the placement of calls via the Company;
- B. any and all use of the Services provided by the Company, including calls which the Customer did not individually authorize. Such calls include calls that constitute PBX fraud and other types of fraud; and
- C. any calls placed by or through the Customer's or its Authorized User's equipment via any remote access feature(s).

- 2.6.2 Americatel's bills are due upon receipt.

- 2.6.3 All charges due by the Customer are payable to Americatel or any agency duly authorized to receive such payments. Terms of payment shall be according to the rules and regulations of Americatel or its agent and subject to the rules of appropriate regulatory agencies. Disputes with respect to billed charges must be presented to Americatel within sixty days from the bill issue date, or such charge shall be deemed correct and binding on Customer. Adjustments to Customers' bills shall be made by Americatel or its agent to the extent that circumstances exist which reasonably indicate that such changes are appropriate. The undisputed portion of the relevant bill and all subsequent bills must continue to be paid on a timely basis.

SECTION 2 - REGULATIONS, (CONT'D.)

2.6 Payment for Services, (Cont'd.)

2.6.4 Late Payment, Charges and Collection Fees

A. For the 1010-123, 1010-719 and 101-6868 services:

Bills set to a Customer by the Company are due and payable within 21 days from the invoice date. A late payment fee of \$1.50 plus a rate of one and one-half percent (1.5%) per month, or the maximum rate allowed by law, shall be charged on any amount remaining unpaid, including late payment charges, at the time the next bill is prepared.

2.6 Payment for Services, (Cont'd.)

- 2.6.6 The Customer shall be liable to Americatel for the cost of collection of all charges owed to Americatel. Collection fees on unpaid charges will accrue at a rate above. Collection fees on unpaid charges shall begin to accrue when the account is assigned to an outside collection agency. Such collection fees are separate and distinct from attorney's fees and other costs incurred in collecting charges owed to Americatel.
- 2.6.7 Customers may refer billing disputes and any other complaints to Americatel at 1-800-501-0123 [for 1010123 and 10-15-688 Ametex service] and 1-800-827-3374 [for 1010-719 and 101-6868 service].
- 2.6.8 If Americatel incurs any fees or expenses, including attorneys' fees, in collecting, or attempting to collect, any charges owed Americatel other than hiring a collection agency (and before filing a lawsuit or commencing another proceeding), the Customer will be liable to Americatel for the payment of all such fees and expenses reasonably incurred.
- 2.6.9 If notice from the Customer of a dispute as to charges is not received in writing by the Company within thirty (30) days after delivery of an invoice to the custody of the U.S. Mail or other standard delivery service, the billing will be considered correct and binding.

SECTION 2 - REGULATIONS, (CONT'D.)

2.6 Payment for Services, (Cont'd.)

2.6.10 If Americatel initiates legal proceedings to collect any amount due hereunder and Americatel substantially prevails in such proceedings, then the Customer shall pay the reasonable attorneys fees and costs of Americatel in prosecuting such proceedings and appeals therefrom. In the event that Americatel suspends the provision of Services to the Customer pursuant to the provisions of this Tariff, Americatel will re-connect the Customer to such Services only when all debts of the Customer to Americatel, including accrued interest and other expenses and costs of collection, have been fully discharged to the satisfaction of Americatel.

2.6.11 LEC Billing Fee

The Company will assess a Regulatory Assessment Fee on the 1010-719 and the 101-6868 services. This fee is assess on all interstate and international long distance usage at a rate of 11.9%. The fee recovers the cost of billing through the Customer's local exchange carrier. It is assessed only in months when there is applicable dial-around usage. This fee is not a tax or charge required by the Government.

2.6.12 All applicable taxes, fees, charges, exactions, or the like which must be paid to any governmental authority - federal, state, local, municipal or otherwise - for the provision of telecommunications services and which, pursuant to the rules and regulations governing such applicable taxes, fees, charges, exactions or the like, may be charged directly to the Customer, will be separately stated on the Customer's bill and charged to, and collected from, the Customer. It shall be the responsibility of the Customer to pay these taxes, and to accept the liability of any such unpaid taxes that may subsequently become applicable retroactively.

SECTION 2 - REGULATIONS, (CONT'D.)

2.6 Payment for Services, (Cont'd.)

2.6.12 (Cont'd.)

A. The Universal Service Fund (USF) Charge

The 1996 Telecommunications Act requires all long distance companies to contribute a portion of their revenues to the Federal Universal Service Fund which provides discounted telecommunications services to schools, libraries and low income customers in rural areas. The USF Charge is collected from telecommunications carriers and administered by the Universal Service Administration Corporation who is responsible for disbursing the funds according to eligibility criteria established by the FCC. By law, carriers are permitted to pass on this USF Charge to recover it from their customers.

This Universal Service Fund (USF) charge will be identified on the bill as "Federal Universal Service – Interstate" and will be found in the "Other fees" section of the bill.

The FCC Contribution factor is subject to change quarterly. The current factor can found at http://www.fcc.gov/wcb/universal_service/quarter.html.

B. USF Administrative Charge

By law, carriers are permitted to recover from their customers the costs they incur in administering the recovery of the USF Charge from their end users. Americatel will recover this USF Administrative Charge from its customers, where applicable. This charge may appear separately on the customer's bill.

SECTION 2 - REGULATIONS, (CONT'D.)

2.6 Payment for Services, (Cont'd.)

2.6.13 Adjustment to Rates and Charges

Americatel may change the per-minute rates and charges from time to time. For changes in the rates to the 1010123 and 10-15-688 Ametex services, refer to the website www.americatel.com.

For the 1010-719 service refer to the website www.startec.com; for changes in rates to the 101-6868 service, refer to the website www.101-6868.com.

SECTION 2 - REGULATIONS, (CONT'D.)

2.7 Billing Entity Conditions

When billing functions on behalf of Americatel are performed by local exchange telephone companies, or others, the payment conditions and regulations of such companies apply, including any applicable interest and/or late payment charge conditions.

2.8 Liability of the Customer

The Customer, and not Americatel, shall be liable for damage to an Underlying Carrier's facilities used to provide Services under this Tariff if such damage is caused by the negligence or willful act of the Customer or its agent(s), or if such damage result from the improper use of the Underlying Carrier's facilities by the Customer or its agent(s). Nothing in the foregoing sentence shall be interpreted to hold one Customer liable for another Customer's actions.

2.9 Use of Service

2.9.1 The Services offered hereunder may be used to transmit communications of the Customer in a manner consistent with the terms of this Tariff, the policies and regulations of the Federal Communications Commission and the requirements of the Communications Act of 1934, as amended. The Services offered hereunder shall not be used for any unlawful purpose.

2.9.2 The use of Americatel's services without payment for service, except as expressly authorized by Americatel in connection with its own promotional activities or the promotional activities of its affiliated companies, and/or any attempt to avoid payment for service by fraudulent means or devices, schemes, false or invalid numbers, or false calling or credit cards is prohibited.

SECTION 2 - REGULATIONS, (CONT'D.)

2.10 Interruption of Service

- 2.10.1 Without incurring liability, Americatel may interrupt the provision of services at any time in order to perform tests and inspections to assure compliance with regulations set forth in this Tariff and applicable law, and may continue such interruption without liability until any items of non-compliance so identified are rectified.
- 2.10.2 Americatel will consider Customer requests for credit for faulty or incorrect connections and for other problems experienced by customers in the use of the Americatel's services on a case-by-case basis, and will provide reasonable credit in those cases in which it determines that the request is justified and Americatel was at fault. All credit allowances shall be subject to the provisions of Section 2.3 above. It shall be the obligation of the Customer to notify Americatel immediately of any service problems for which a credit allowance is desired. Before giving such notice, the Customer shall ascertain that the problem experienced is not being caused by any action or omission by the Customer within the Customer's control.

SECTION 2 - REGULATIONS, (CONT'D.)

2.11 Restoration of Service

The use and restoration of Service shall be in accordance with the priority system specified in Part 64, Subpart D of the Rules of the Federal Communications Commission.

2.12 Billing Arrangements

Customers will either be billed directly by Americatel or its intermediary or agent or charges will be included in the Customers' regular telephone bills pursuant to billing and collection agreements established by Americatel or its intermediary or agent with the applicable telephone company. Americatel may refuse to complete calls made by and Collect Calls made to persons who receive regular telephone bills from a telephone company where for economic, technical and/or operational reasons Americatel or its intermediary does not have an effective billing and collection agreement. To determine when calls cannot be completed according to Americatel's records, call 1-800-531-0457.

SECTION 2 - REGULATIONS, (CONT'D.)

2.13 Timing of Calls

2.13.1 When Billing Charges Begin and Terminate for Phone Calls

The chargeable time for a long distance call is determined by the duration of the call. Chargeable time for Message Telecommunications Service begins when the called party answers the call and two-way communications are established. A call is deemed "answered" for the purpose of calculating chargeable time when network hardware detects a completed connection through answer supervision, in which the local telephone company sends a signal to the switch or software utilizing either digital format or audio tone detection. Unanswered calls will not be billed. Chargeable time for Collect Calls begins when the called party accepts responsibility for payment. Chargeable time ends when the calling or called station hangs up or otherwise terminates the call.

2.13.2 Billing Increments

Unless otherwise specified in this Tariff, the minimum call duration for billing purposes for the 1010123 service is one minute for a connected call. Customers will not be billed for calls of 6 seconds or less. After the first 6 seconds of a call, the customer will be billed for 1 minute. Calls beyond 1 minute are billed in one minute increments.

For the 1010-719 and 101-6868 the service is billed in increments of one minute.

2.13.3 Uncompleted Calls

There shall be no charge for uncompleted calls.

SECTION 2 - REGULATIONS, (CONT'D.)

2.14 Deposits

Americatel may require a Customer without an established credit history to pay a sum up to an amount equal to two (2) month's estimated charges as a deposit. Such deposit will be held as a guarantee of the payment of charges provided for herein. The fact that a deposit has been made in no way relieves the Customer from complying with the prompt payment of bills on presentation. At such time as service is terminated, the amount of the deposit will be credited to the Customer's account and any credit balance which may remain will be refunded. Such a deposit may be refunded or credited to the Customer at any time prior to termination of the service at the option of Americatel.

2.15 Advance Payments

Americatel reserves the right to collect an amount not to exceed one (1) month's estimated charges as an advance payment for services. The advance payment will be applied against the next month's charges and, if necessary, a new advance payment will be collected for the following month. Americatel may require advance payments any Customer if, in Americatel's sole discretion, such payment(s) will be necessary to guarantee payment from Services

2.16 Failure to Notify or Enforce

The failure of Americatel to give notice of default, to enforce or to insist upon compliance with any of the terms or conditions herein, the waiver of any terms or conditions herein, or the granting of an extension of time for performance by the Customer shall not constitute a waiver of any term or condition herein. Each of the provisions of this Tariff shall remain at all times in full force and effect unless and until modified in writing.

2.17 Trade Names, Trademarks, Service Marks and Registered Marks

Neither the Customer nor the Company shall use the other's trade names, trademarks or service marks ("Marks") without the prior written approval of the other party. Neither shall they display or use the other's Marks, nor permit the same to be displayed or used by third parties. Nothing in this tariff creates in a party rights in the Marks of the other.

SECTION 3 - DESCRIPTION OF SERVICE AND RATES

3.1 Message Telecommunications Service ("MTS")

Americatel offers casual dial around service to residential, business and other customers. Service is available on a full-time basis, 24 hours a day, seven days a week. For casual dial-around non-presubscribed service, the Customer dials 101-0123, then 1 or 011, and the destination or country code and number. Message Telecommunications Service is not available from transient locations such as hospitals, hotels, university dormitories or prisons, and is not available from cellular or pay telephones. Americatel may add or modify the dial around access numbers at its discretion. This Tariff applies to the Customer's use of MTS service on a prescribed basis, but only until the Customer has entered into a Service Agreement with Americatel or until forty-five (45) days after service has been established. Provided, however, that if a Customer makes any calls on a presubscribed basis after the expiration of this 45-day period, but without entering into a service agreement, the Customer will be deemed to have accepted Americatel's Rates, Terms, and Conditions for service as set forth on Americatel's Internet web site, until such time as the Customer cancels its presubscribed plan with Americatel.

SECTION 3 - DESCRIPTION OF SERVICE AND RATES, (CONT'D.)

3.2 Directory Assistance

3.2.1 General Description of Service

Directory Assistance is a service that that allows callers to obtain telephone numbers for locations in the United States as well as in Canada, and certain Caribbean locations.

3.2.2 Dialing Instructions

For domestic locations and for those in Canada and certain Caribbean locations having NPAs that are part of the North American Numbering Plan, dial the appropriate access code to reach the Americatel network, plus the NPA (area code) for the telephone number desired, plus 555-1212.

3.2.3 Directory Assistance in the U.S.

A Directory Assistance Charge applies to all calls made from points within the United States to: Directory Assistance in certain International Caribbean locations (Anguilla, Antigua/Barbuda, Bahamas, Barbados, Bermuda, British Virgin Islands, Cayman Islands, Dominica, Dominican Republic, Grenada, Jamaica, Monsterrat, St. Kitts/Nevis, St. Lucia, St. Vincent/Grenadines, Trinidad/Tobago, and Turks/Caicos Islands).

3.2.4 Directory Assistance in Canada

This charge applies whether or not the Directory Assistance bureau furnishes the requested telephone number (e.g., where the requested telephone number is unlisted, non-published, or no record can be found).

3.3 Message Telecommunications Service Rates

3.3.1 International Rates: 10-10-123 Casual Dial Around Service

A. Interstate Calls

Call duration for billing purposes is 1 minute for a connected call. Customers will not be billed for calls of 6 seconds or less. After the first 6 seconds of a call, the Customer will be billed for 1 minute. Calls beyond 1 minute are billed in 1 minute increments.

B. International Calls

Customers will not be billed for calls of 3 seconds or less. After the first 3 seconds, and up to the first minute of the call, the customer will be billed for 1 minute. Calls from 1 minute up to 3 minutes inclusive will be billed for 3 minutes. Calls beyond 3 minutes will be billed in 3 minute increments. Fractional increments will be rounded upward to the full increment.

A. Universal Service Fund Charge

The 1996 Telecommunications Act requires all long distance companies to contribute a portion of their revenues to the Federal Universal Service Fund which provides discounted telecommunications services to schools, libraries and low income customers in rural areas. The USF Charge is collected from telecommunications carriers and administered by the Universal Service Administration Corporation who is responsible for disbursing the funds according to eligibility criteria established by the FCC. By law, carriers are permitted to pass on this USF Charge to recover it from their customers.

This Universal Service Fund (USF) charge will be identified on the bill as "Federal Universal Service – Interstate" and will be found in the "Other fees" section of the bill.

The FCC Contribution factor is subject to change quarterly. The current factor can found at http://www.fcc.gov/wcb/universal_service/quarter.html.

1. USF Administrative Charge.

By law, carriers are permitted to recover from their customers the costs they incur in administering the recovery of the USF Charge from their end users. Americatel will recover this USF Administrative Charge from its customers, where applicable. This charge may appear separately on the customer's bill.
