The accompanying tariff material, issued by Verizon Long Distance LLC and bearing Tariff FCC No. 11 and Tariff FCC No. 12, effective January 1, 2012, is sent to you for filing in compliance with the requirements of the Communications Act of 1934, as amended. This filing is made on one (1) day's notice.

The purpose of this filing for the Domestic Tariff FCC No. 11 is to increase the Universal Service Fund fee for the 1st Quarter of 2012. Pursuant to Report and Order FCC 11-92 WC Docket No. 10-141 Released 6/9/2011; effective as of November 17, 2011, this filing also revises the tariff to make administrative changes consistent with current FCC rules for ETFS filed tariffs. This filing also increases the Federal Access Charges rates for Single Line Business Customers and Centrex/CustoPak Customers. Customers have been notified of these increases via bill messages.

For International Tariff FCC No. 12, this filing increases the Universal Service Fund fee for the 1st Quarter of 2012. Pursuant to Report and Order FCC 11-92 WC Docket No. 10-141 Released 6/9/2011; effective as of November 17, 2011, this filing also revises the tariff to make administrative changes consistent with current FCC rules for ETFS filed tariffs.
