SECTION 5 - MISCELLANEOUS CHARGES

5.1 End User Common Line

The Company recovers some of the costs of the telephone line or trunk connected to the customer's premises through a monthly charge called the End User Common Line Charge. The End User Common Line charge is a monthly, flat-rated charge assessed to end users for each local exchange service line or trunk. The End User Common Line charge will be based on a monthly snapshot of end user accounts. Fractional debits or credits will be assessed for partial months due to service installs and disconnects.

When a customer is provided more than one local business exchange service in a state by the same Company, the EUCL Multi-line Business Subscriber rates are assessed for each line.
