The accompanying tariff material, issued by Pioneer Communications (“Pioneer”), under FRN: 0002334795, and bearing Tariff F.C.C. No. 1, Access Services, is sent to you in accordance with the FCC’s Orders, DA 12-482, *In the Matter of July 3, 2012 Annual Access Charge Tariff Filings*, WCB/Pricing File No. 12-07, released March 28, 2012, and DA 12-575, *In the Matter of Material to be Filed in Support of 2012 Annual Access Tariff Filings*, WCB/Pricing File No. 12-08, released April 19, 2012.
