Issuing Carriers

Accompanying this transmittal letter at Appendix A is a table listing the issuing carriers for JSI Tariff F.C.C. No. 1 which indicates the types of rate changes, if any, being made under this transmittal on behalf of each issuing carrier. For the existing issuing carriers that are subject to Section 61.38, of the Federal Communications Commission (“FCC” or “Commission”) rules, this filing includes the traditional Tariff Review Plan (“TRP”) and supporting information in order to comply with the rules and regulations of the FCC with respect to annual access charge filings.

For the existing issuing carriers that are subject to Section 61.38 or Section 61.39 of the FCC’s rules, this filing is also being made in compliance with new rules adopted by the Commission in its USF/ICC Transformation Order requiring ILECs to adjust, over a period of years, their switched access charges effective on July 1 of each of those years together with introduction of an Access Recovery Charge (“ARC”) and requiring ILECs to make a Connect America Fund (“CAF”) election pursuant to Section 51.917(f) of the Commission’s rules. *See Connect America Fund et al.*, WC Docket No. 10-90 et al., Report and Order and Further Notice of Proposed Rulemaking, 26 FCC Rcd 17663, FCC-11-161 (Rel. November 18, 2011), (*USF/ICC Transformation Order*), pets. for review pending, Direct Commc’ns Cedar Valley, LLC v FCC, No. 11-9581 (10th Cir. Filed Dec. 18, 2011) (and consolidated cases). All of the JSI Tariff Issuing Carriers have elected to begin assessing an ARC as of July 3, 2012, and have also certified their eligibility to receive CAF support in conjunction with this filing.

Lastly, this filing is being made to implement the reduced Federal Universal Service Charge (“FUSC”) quarterly filing for Knology of the Valley, Inc. Of the existing issuing carriers for JSI Tariff F.C.C. No. 1 who make mandatory filings on odd-numbered years pursuant to Section 61.39 of the Commission’s rules, none have elected to make mid-course voluntary annual filings.

Request for Confidential Treatment of designated Tariff Review Plan Information

In conjunction with this filing, JSI is filing a Request for Confidential treatment with the FCC pursuant to Section 0.459 of the Commission’s rules,¹ withholding from public inspection, specific data as described in that Request, that is contained in the Tariff Review Plans being submitted in conjunction with the annual JSI Tariff filing. Pursuant to the standard protective order which sets forth the procedure that should be followed by parties requesting access to confidential information submitted with tariffs filed pursuant to section

204(a)(3) of the Telecommunications Act,² the pages of the TRPs containing the confidential information are being filed under seal and each such page is marked "CONTAINS PRIVILEGED AND CONFIDENTIAL INFORMATION – DO NOT RELEASE." These pages are also being provided in a redacted format and are marked "Redacted Version for Public View."

FUSC Filing for Knology of the Valley, Inc.

For Knology of the Valley, Inc. ("Knology"), this filing proposes revision of the Federal Universal Service Charge factor reflective of the decrease in the Universal Service Contribution Factor from 17.4% to 15.7% for the third quarter of 2012. See Proposed Third Quarter 2012 Universal Service Contribution Factor, CC Docket No. 96-45, Public Notice, DA 12-917 (released June 11, 2012). Knology is not a member of the National Exchange Carrier Association ("NECA") Common Line Pool and therefore bills common line charges and related FUSC charges pursuant to JSI Tariff FCC No. 1. All remaining issuing carriers for JSI Tariff FCC No. 1 are members of and participate in the NECA Common Line Pool and reference NECA Tariff FCC No. 5 with respect to FUSC rates.

Pursuant to Section 61.32(b) of the Commission's Rules, the original of this letter, Form 159, and a check for \$845.00 have been sent via overnight delivery to U.S. Bank, St. Louis, Missouri, as of this date.

Customers will be notified of the proposed changes in accordance with the Commission's requirements.
