This access service tariff filing proposes to introduce the Access Recovery Charge (ARC) for Residential, Single Line and Multi Line Business Customers per 47 CFR §51.917(e). The ARC is being added to this tariff pursuant to instructions contained in the Policy and Planning Division's (PPD) March 28, 2012 (DA 12-482) and April 19, 2012 (DA 12-575) Orders.

The companies included in this tariff, Columbus Telephone Company, LaHarpe Telephone Company, and Lake Livingston Telephone Company (Issuing Companies), state the following in regards to this Tariff filing. The FRN for each of these companies is listed below.

Each of the Issuing Companies (Columbus Telephone Company, LaHarpe Telephone Company and Lake Livingston Telephone Company) hereby elects to receive Connect America Fund (CAF) intercarrier compensation (ICC) recovery pursuant to 47 CFR §51.917(f).

Pursuant to the PPD's April 19, 2012 Order, each of the Issuing Companies is providing all material required to be filed in the Tariff Review Plans (TRP). This information is also being provided to establish each of the Issuing Companies' assessment of the ARC rate and the projected eligibility for CAF ICC funding during the upcoming funding period, as required by 47 CFR §54.304(d)(1) and pursuant to 47 CFR §51.917. Each of the Issuing Companies is providing a signed certification, pursuant to paragraph 31 of that Order, that the information contained in the TRP is true, correct, and complete to the best of the Company's knowledge.

Each of the Issuing Companies is also providing certifications in regard to 47 CFR §51.917(f)(3), which relates to compliance with 51.917(d) and (e) and is eligible to receive the CAF ICC support requested, and 47 CFR 51.917(d)(vii), which states that the Company is not seeking duplicative recovery in the state jurisdiction.

Pursuant to Commission's Rules, an electronic letter of transmittal with signature, Form 159, and payment for \$845.00 has been made through the FCC Fee Filer System as of this date.
