Dear Ms. Dortch,

On behalf of IntelePeer, Inc. ("IntelePeer"), enclosed are the pages for FCC Access Services Tariff No. 1, revised to comply with the directive of the Federal Communications Commission ("FCC") in 47 C.F.R. §51.907 and § 51.911 regarding reductions to the rates for intrastate switched access services across the country.

The FCC ordered carriers to lower intrastate access rates 50% toward the interstate rates by July 1, 2012, and the remaining 50% by July 1, 2013, based on access revenues. IntelePeer has had no switched access revenues, and had set its interstate switched access rates at the rates of the corresponding incumbent carrier in each jurisdiction. To streamline its compliance, IntelePeer intends to (1) adopt the lowest interstate rates charged by any incumbent carrier as its set interstate rates; (2) lower its intrastate rates to interstate levels by July 1, 2012; and (3) then incorporate those rates into all of its intrastate tariffs, which results in several new rate elements, created from breaking up some blended, composite rates.
