This filing modifies Section 6 (Switched Access Service) to introduce new provisions in compliance with the Federal Communication Commission's ("Commission's") Intercarrier Compensation rule change that become effective on December 29, 2011.¹ These changes address treatment of Toll Voice over Internet Protocol – Public Switched Network (VoIP-PSTN)
