On June 18, 2012, NBTC issued its 2012 Annual Filing under Transmittal No. 232 in NBTC Tariff F.C.C. No. 1. Transmittal No. 232 was scheduled to become effective on July 3, 2012.

This supplement is filed pursuant to Wireline Competition Bureau's Order (Order) DA12-1037, *In the Matter of July 3, 2012 Annual Access Charge Tariff Filings*, WCB/Pricing No. 12-09.
