3.4.4 Rates (cont'd)

(h) Business Account Fee

The Business Account Fee defrays costs incurred by the Company in processing, maintaining and sending monthly paper bills associated with serving business accounts. Customers that forego receiving monthly bill detail and opt for receiving the bill summary page only will be exempt from the Business Account Fee.
