In addition, special construction nonrecurring charges for the installation of fiber optic cable in order to satisfy the requirements of customers in the states of Florida, Indiana, Kansas, Minnesota, Missouri, North Carolina, Ohio, Oregon, Pennsylvania, Tennessee, Texas, South Carolina and Virginia are included.
