This amended application for special permission replaces the transmittal for Application No. 6. The original filing did not include the illustrative tariff pages.

This application for special permission requests waiver of the requirements of Section 61.74 of the Federal Communication's Commission's Rules in order to make reference in CenturyLink Operating Companies Tariff F.C.C. No. 9 Section 24, Contract No. 12-001, to the similar contract tariff of Qwest Corporation (QC) Tariff F.C.C. No. 1, Contract No. 12-003..

With this filing CenturyLink is proposing to offer a DS1 and DS3 Price Flex Contract (No. 12-001), which requires concurrent subscription to the Qwest Corporation Tariff F.C.C. No. 1, Contract No. 12-003.

In this regard, CenturyLink requests permission to waive Section 61.74 of the Commission's rules in order to include the above mentioned tariff reference in its proposed contract tariff filing. An application to waive 61.74 of the Commissions' Rules is also being requested by Qwest in a separate filing.

Illustrative tariff pages for Contract No. 12-001 are included with this application for CenturyLink Operating Companies Tariff F.C.C. No. 9.
