1ST AMENDMENT TO THIS CONTRACT TARIFF

AMENDMENT

EFFECTIVE DATE: October 10, 2012

This Contract Tariff Amendment extends the end date of the original contract tariff from February 17, 2014 to December 31, 2020. In addition other changes may be found A and B following:

- A. The 12-month Eligibility for Overlay Plan Discounts, identified in number 1. of the original contract tariff preceding, the following 12-month agreement years have been added below. The last discount will be prorated to the partial year:
- February 18, 2014 through February 17, 2015
 - February 18, 2015 through February 17, 2016
 - February 18, 2016 through February 17, 2017
 - February 18, 2017 through February 17, 2018
 - February 18, 2018 through February 17, 2019
 - February 18, 2019 through February 17, 2020
 - February 18, 2020 through December 31, 2020
- B. The 12-Month Volume-Based Credits, identified in number 3. of the original contract tariff preceding, will be applied through December 31, 2020. The last credit will be prorated to the partial year.
- C. All other terms and conditions set forth in the original contract tariff preceding will remain in effect.
