23.WWW.1 General Description

This Special Access Service Offer (Contract Offer No. WWW) is an access services plan for which concurrent subscription is required to this Contract Offer and the following Access Tariffs: The Southern New England Telephone Company(SNET) Tariff F.C.C. No. 39, Contract Offer No. YYY; Pacific Bell Telephone Company (PBTC) Tariff F.C.C. No. 1, Contract Offer No. XXX; BellSouth Telecommunications, LLC (BellSouth) Tariff F.C.C. No. 1, Contract Offer No. VVV; Ameritech Operating Companies (Ameritech) Tariff F.C.C. No. 2, Contract Offer No. UUU, and Southwestern Bell Telephone Company (SWBT) Tariff F.C.C. No. 73, Contract Offer No. ZZZ (collectively, with this Contract Offer No. WWW, "Concurrently Subscribed Contract Offers"). Ameritech, PBTC, SNET, BellSouth and SWBT, with the Telephone Company, shall be identified herein as the "Qualified Companies."

This Contract Offer permits Customers that meet the Eligibility Criteria in Section 23.WWW.3, and the Terms and Conditions in Section 23.WWW.4, to disconnect Subject Services, as defined in Section 23.WWW.2, without incurring termination liability charges.
