The Verizon Telephone Companies (Verizon) hereby apply for Special Permission for a waiver of Section 61.74 of the Commission's rules.

Verizon intends to introduce a new contract tariff option in its Access Service Tariff FCC No. 1 (FCC1), Access Service Tariff FCC No. 11 (FCC11), and Facilities for Interstate Access Tariff FCC No. 14 (FCC14). The new contract tariff option provides billing credits for certain Special Access DS1 and DS3 services when the customer meets conditions as further described in the new contract tariff option.

Verizon requests special permission to waive the requirements of Section 61.74 of the Commission's rules in order to allow FCC1, FCC11, and FCC14 to make the following references to each other and to Tariff FCC No. 16 (FCC16):

- * FCC1 and FCC11 must reference each other for the purpose of identifying Facilities Management Service included under this new contract tariff option, and the section numbers where the regulations for such services are found.
- * FCC1, FCC11, and FCC14 must reference each other and FCC16 for the purpose of identifying the DS1 and DS3 capacity services included in this new contract tariff option, and the section numbers where the regulations for such services are found.

- * FCC1, FCC11, and FCC14 must reference each other for the purpose of specifying that the customer's subscription to the contract tariff option in one of the tariffs shall be an automatic subscription to the contract tariff option in the other tariffs.
- * FCC1, FCC11, and FCC14 must reference each other for the purpose of defining the Metropolitan Statistical Areas that comprise the Serving Area for the new contract tariff option and in which Billing Credits apply.
- * FCC1 and FCC11 must reference FCC14 and FCC16, and FCC14 must reference FCC16 for the purpose of excluding MetroLAN services from this new contract tariff option.
- * FCC1, FCC11, and FCC14 must reference each other for the purpose of identifying certain minimum period and early termination charges to be included in the definition of Monthly Recurring Charges in the new contract tariff option and the section numbers where the regulations for such minimum period and early termination charges are found.
- * FCC1, FCC11, and FCC14 must reference each other and FCC16 for the purpose of identifying when a bill has been "paid in full".
- * FCC1, FCC11, and FCC14 must reference each other for the purpose of specifying the impact that a customer merger or acquisition will have on the contract tariff option.
- * FCC1, FCC11, and FCC14 must reference each other for the purpose of specifying the impact that a sale or transfer of some or all of the assets or stock of a Verizon Operating Telephone Company will have on the contract tariff option.
- * FCC1, FCC11, and FCC14 must reference each other for the purpose of specifying the effect that cancellation of the customer's subscription to the contract tariff option in one of the tariffs will have on the customer's subscription to the contract tariff option in the other tariff.

This application and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS).

Payment in the amount of \$845.00 has been electronically transmitted to the U.S. Bank in St. Louis, Missouri, in accordance with the fee program procedures.
