The Accompanying tariff material, issued by North County Communications Corporation ("NCC") (FRN: 0005796693), and bearing FCC Tariff No. 2, is being filed electronically on March 4, 2013. NCC and its subsidiaries are competitive local exchange carriers ("CLECs").

This filing clarifies, at 2<sup>nd</sup> Revised Sheet No. 9, that NCC's switched access charges do not apply to the transmission of interexchange traffic to or from "End Users" who are neither paying subscribers to NCC's telecommunications or interconnected or non-interconnected VoIP services, nor paying subscribers to such services furnished by another service provider that is jointly providing switched access service with NCC.

This filing also corrects the pagination of various sheets that were mis-numbered during preparation of NCC's Amended Transmittal No. 10, which was issued on January 6, 2012 and became effective on January 15, 2012. The previously mis-numbered sheets are as follows:

In accordance with the Commission's fee filing requirements, a filing fee in the amount of \$845.00 has been paid by credit card and an electronic Form 159 has been submitted.


