On December 14, 2012, the Verizon Telephone Companies (Verizon) filed Application No. 206, requesting a waiver of Section 61.74 of the Commission's rules in order to introduce an optional national service level agreement plan in its Tariff FCC Nos. 1, 11 and 16, Access Service; and Tariff FCC No. 14, Facilities for Interstate Access.
