CenturyLink Operating Companies Tariffs F.C.C. No. 11 and 12 are being filed under authority of Special Permission No. 13-005 of the Federal Communications Commission. On its effective date, these tariffs will replace the existing Qwest Corporation Tariffs F.C.C. No. 1 and No. 2 which are being cancelled by Qwest Supplement No. 7 in Tariff F.C.C. No.1 and Qwest Supplement No. 1 in Tariff F.C.C. No. 2. The regulations, rates and charges contained in CLOC Tariffs No. 11 and No. 12 are identical to those found in the current Qwest Tariffs with the exception of minor textual changes necessary to reflect the revised page numbers and ensure consistent heading and references.

In accordance with the requirements of Section 61.21(a)(3) of the Commission's Rules, the FCC Registration Number (FRN) for CenturyLink is 0018-6268-53. CenturyLink is filing this transmittal on behalf of issuing carriers on Attachment A.
