With this filing, BellSouth is proposing to sunset Maritime Mobile Radiotelephone Service. There is no demand for this service. Pursuant to the FCC's *CMRS Second Report and Order*, the FCC classified maritime mobile services (Part 80, subpart J), except high seas service, as CMRS service and simultaneously, granted forbearance from the FCC's 214 approval requirements for these services.
