**2.1 LIMITATIONS ON SERVICE**

- Service is offered subject to the availability of facilities and the provisions of the tariff.
- Qwest reserves the right to immediately discontinue furnishing services or billing options, when the manner in which the customer uses Qwest's service results, or may result, in network blockage or other service degradation which adversely affects service to the calling party, the customer, or other customers of Qwest. Qwest also reserves the right to immediately discontinue furnishing services or billing options, when the customer is using the service in violation of the provisions of this tariff or in violation of the law. The customer will be responsible for all charges incurred as well as any access charges Qwest may incur as a result of such customer actions.
- Service may be discontinued by Qwest, at any time and without notice to its customers, by blocking traffic to or from certain countries, cities, NXX exchanges, or individual telephone stations, by blocking call origination for Qwest services, or by blocking calls using certain customer authorization codes and/or access codes, when Qwest deems it necessary to take such action to prevent unlawful and/or unauthorized use of its services. In addition, Qwest may take any of the foregoing actions in the case of actual or anticipated non-payment for its service. In order to control fraud, Qwest may refuse to accept Calling Card, Collect Calling and/or Third Party calls which it reasonably believes to be unauthorized or invalid and/or may limit the use of these billing options to or from certain countries or areas including, without limitation, all or part of the United States, Puerto Rico and/or the U.S. Virgin Islands.
- A customer shall not: (i) use any service mark or trade mark either of Qwest or any of its affiliated companies or of which Qwest or any of its affiliated companies is a licensee, or (ii) refer to Qwest or any of its affiliated companies in connection with any service, product, equipment, offering, promotion or publication of the customer or of a third party on behalf of or with the authorization of the customer, without the prior written approval of Qwest and its pertinent affiliated company.
- Title to all facilities provided by Qwest under these regulations remains with Qwest.
- To the extent applicable, Qwest service will be subject to the most recent conditions set forth in the Truth in Lending Act, Reg Z, 12 C.F. R. Section 226.

**2.2 TERMS AND CONDITIONS**

- If Qwest disconnects a customer's Qwest service for non-payment of past due amounts, the customer's service will remain disconnected until such time as Qwest receives payment for all past due amounts and confirms the availability of sufficient funds to satisfy the amount of payment.
- Qwest services are provided and billed on the basis of a minimum period of at least one month, beginning on the date that billing becomes effective and continues to be provided until canceled by the customer in writing on not less than 30 days notice from the date of postmark on the letter giving notice of cancellation.
- The name(s), address(es), and telephone number(s) of the customer(s) desiring to use the service must be stipulated in the application for service.
- The customer agrees to operate Qwest –provided equipment in accordance with instructions of Qwest or Qwest's agent. Failure to do so will void Qwest liability for interruption of Qwest services and may make customer responsible for damage to equipment pursuant to the following paragraph.
- Customer agrees within five (5) days of termination of the service in connection with which the equipment was used to return to Qwest all Qwest – provided equipment delivered to customer. Said equipment shall be in the same condition as when delivered to customer, normal wear and tear excepted. Customers shall reimburse Qwest, upon demand, for any costs incurred by Qwest due to customer's failure to comply with this provision.

**2.3 LIABILITY**

- Except for granting allowances for interruptions of service as provided for in this and other sections of this tariff, Qwest shall not be liable for any failure of performance due to: causes beyond its control, including, but not limited to, acts of God, fires, floods or other catastrophe, national emergencies, insurrections, riots or wars, strikes, lockouts, work stoppages or other labor difficulties; preemption of existing services to restore service in compliance with Part 64, Subpart D, Appendix A, of the FCC's Rules and Regulations; or any law, order, or action of any governing authority or agency thereof.
- Qwest's liability, if any, with regard to the delayed installation of Qwest facilities or commencement of services shall not exceed \$1,000 irrespective of the circumstances. With respect to any other claim or suit, by a customer or by any others, for damages associated with the ordering (including the reservation of any specific number for use with a service), installation (including delays thereof), provision, termination, maintenance, repair, interruption, or restoration of any service or facilities offered under this tariff, and subject to the provisions following, Qwest's liability, if any, shall be limited as follows:
  - With respect to any service provided by Qwest which involves dedicated access, shared interexchange transmission and/or shared termination, Qwest's liability shall not exceed an amount equal to the proportionate monthly recurring charges--including any service charges, minimum monthly charges, basic feature package charges, monthly charges for optional features, charges for dedicated access facilities and any other monthly charges--for the period during which the service was affected or, if only a transmission using the shared interexchange facilities is interrupted, an amount equal to the charge applicable to a one minute call to the called station at the time the affected call was made.

**2.3 LIABILITY (Cont'd)**

- With respect to any service provided by Qwest which involves shared access, shared interexchange transmission, and/or shared termination, Qwest's liability shall not exceed an amount equal to the charge applicable to a one minute call to the called station at the time the affected call was made.
- With respect to the routing of calls by Qwest to public safety answering points or municipal emergency service providers, Qwest's liability, if any, will be limited to the lesser of: (a) the actual monetary damages incurred and proved by the customer as the direct result of Qwest's action, or failure to act, in routing the call; or (b) the sum of \$1,000.00.
- With respect to Qwest's offering of Telecommunications Relay Service (TRS), any service provided by Qwest which involves receiving, translating, transmitting, or delivering messages by telephone, text telephone, a Telecommunications Device for the Deaf, or any other instrument over the facilities of Qwest or any connecting carriers or through any TRS centers operated by Qwest or its agents, Qwest's liability shall not exceed an amount equal to Qwest's charge for a one minute call to the station at the time the affected call was made.
- The liability provided for above, shall in each case, be in addition to any amounts that may otherwise be due the customer under this tariff as a credit allowance for the interruption of service.

**2.3 LIABILITY (Cont'd)**

- Qwest shall be indemnified, defended, and held harmless by the customer or by others authorized to use the service against all claims of loss or damage arising from the use of service furnished under this tariff, including:
  - claims for libel, slander, invasion of privacy, or infringement of copyright arising out of the material, data, information, or other content transmitted via Qwest service;
  - patent infringement claims arising from combining or connecting Qwest service with apparatus and systems furnished by the customer or others; and
  - all other claims arising out of any act or omission of the customer or others in connection with any service provided by Qwest.
- Qwest shall not be liable for any act or omission of any other company or companies furnishing a portion of the service, or for damages associated with service, circuits, or equipment that it does not furnish, or for damages which result from the operation of customer-provided systems, equipment, facilities or services which are interconnected with Qwest services.
- Qwest does not guarantee, nor make any warranty with respect to service installations at locations at which there is present an atmosphere that is explosive, prone to fire, dangerous or otherwise unsuitable for such installations. The customer and user shall indemnify and hold Qwest harmless from any and all loss, claims, demands, suits or other actions, or any liability whatsoever, whether suffered, made, instituted or asserted by the customer by any other party, for any personal injury to, or death of, any persons, and for any loss, damage or destruction of any real or personal property, whether owned by the customer or others, caused or claimed to have been caused, directly or indirectly, by the installation, operation, failure to operate, maintenance, removal, presence, condition, location or use of service furnished by Qwest at such locations.

**2.3 LIABILITY (Cont'd)**

- Qwest is not liable for any defacement of, or damage to, the premises of a customer resulting from the furnishing of service, or the attachment of any instruments, apparatus associated wiring on such customers premises or from the installation or removal thereof, when such defacement or damage is not the result of Qwest negligence. No agents or employees of other participating carriers shall be deemed to be agents or employees of Qwest.
- Qwest shall not be liable for the customers failure to fulfill its obligation to take all necessary steps including, without limitation, obtaining, installing and maintaining all necessary equipment, materials and supplies, for interconnecting the terminal equipment or communications system of the customer, or any third party acting as its agent, to the Qwest network. The customer shall secure all licenses, permits, approvals, rights-of-way, and other arrangements necessary for such interconnection. In addition, the customer shall ensure that its equipment and/or system or that of its agent is properly interfaced with Qwest service, that the signals emitted into Qwest's network are of the proper mode, bandwidth, power, data speed, and signal level for the intended use of the customer and in compliance with the criteria set forth in the following, and that such do not damage Qwest's equipment or network or injure Qwest personal or degrade service to other customers. If the Federal Communications Commission or some other appropriate certifying body certifies terminal equipment as being technically acceptable for direct electrical connection with interstate communications service, Qwest will permit such equipment to be connected with its service without the use of protective interface devices. If the customer or its agent fails to maintain and operate its equipment and/or system or that of its agent properly, with resulting imminent harm to Qwest equipment, network, personnel, or the quality of service to other customers, Qwest may, upon notice, require the use of protective equipment at the customers expense. If this fails to produce satisfactory quality and safety, Qwest may, upon written notice, terminate the customers service without liability or obligation.

**2.3 LIABILITY (Cont'd)**

- With respect to the use and sale of telephone subscriber information provided pursuant to Automatic Number Identification (“ANI”) or charge number services, Qwest shall permit the customer to use the telephone number and billing information for billing and collection, routing, screening, and completion of the originating telephone subscriber’s call or transaction, or for services directly related to the originating telephone subscriber’s call or transaction. The customer is prohibited from reusing or selling the telephone number or billing information without first:
  - notifying the originating telephone subscriber and
  - obtaining the affirmative consent of each subscriber for such reuse or resale. Additionally, the customer is prohibited from disclosing, except as permitted above, any information derived from the Automatic Number Identification (“ANI”) or charge number service for any purpose other than:
    - performing the services or transactions that are the subject of the origination telephone subscriber’s call,
    - ensuring network performance security, and the effectiveness of call delivery,
    - compiling, using and disclosing aggregate information, and
    - complying with applicable law or legal process.
- The requirements listed above shall not prevent a person to whom automatic number identification or charge number services are provided from using:
  - the telephone number and billing information provided pursuant to this service, and
  - any information derived from the automatic number identification or charge number service, or from the analysis of the characteristics of a telecommunications transmission, to offer a product or service that is directly related to the products or services previously acquired by that customer from such person.

**2.4 CANCELLATION OF SERVICE BY A CUSTOMER**

If a customer cancels an order for service before the service begins, before completion of the minimum period, or before completion of some other period mutually agreed upon by the customer and Qwest, a charge will be levied upon the customer for the non-recoverable portions of expenditures or liabilities incurred expressly on behalf of the customer by Qwest and not fully reimbursed by installation and monthly charges. If based on an order by a customer, and construction has either begun or been completed, but no services provided, the non-recoverable cost of such construction shall be borne by the customer.

Except as otherwise provided in this tariff, if an order for installation is delayed for more than 30 days beyond the due date, and such delay is not requested or caused by the customer, the customer may cancel the order without incurring cancellation charges.

**2.5 USE OF SERVICE**

Service furnished by Qwest may be used for one or more of the following:

- for the transmission of communications by the customer.
- for the transmission of communications to or from an authorized user or joint user.
- for the transmission of communications to or from a customer of another common carrier, which has subscribed to Qwest's communications service for purposes of resale.

Service furnished by Qwest may be arranged for joint use or authorized use. The joint user or authorized user shall be permitted to use such service in the same manner as the customer, but subject to the following:

- One joint user or authorized user must be designated as the customer. The designated customer does not necessarily have to have communications requirements of its own. The customer must specifically name all joint users or authorized users in the application for service. Orders that involve the start, rearrangement or discontinuance of joint use or authorized use service will be accepted by Qwest only from that customer and will be subject to all provisions of this tariff.
- All charges for the service will be computed as if the service were to be billed to one customer. The joint user or authorized user which has been designated as the customer will be billed for all components of the service and will be responsible for all payments to the company. In the event that the designated customer fails to pay the company, each joint user or authorized user shall be liable to the company for all charges incurred as a result of its use of Qwest's Service. Each joint or authorized user must submit to the designated customer a letter accepting contingent liability for its portion of all charges billed by Qwest to the designated customer. This letter must specify that the joint or authorized user understands that the company will receive a copy of the guaranty from the designated customer. Unless supportive services are provided, the customer shall be responsible for allocating charges to each joint user or authorized user

**2.6 PAYMENT ARRANGEMENTS**

The customer is responsible for payment of all charges for service furnished to the customer or its joint or authorized users. This responsibility is not changed by virtue of any use, misuse, or abuse of the customers service or customer-provided systems, equipment, facilities, or services interconnected to the customers service, which use, misuse, or abuse may be occasioned by third parties, including, without limitation, the customers employees or other members of the public. Qwest is not liable for any damages, including toll usage charges, the subscriber may incur as a result of the unauthorized use of its telephone facilities. This unauthorized use of the subscriber's facilities includes, but is not limited to, the placement of calls from the subscriber's premises, and the placement of calls through subscriber-provided equipment which are transmitted or carried on the Qwest network. The Qwest security department may work with subscribers to recommend possible solutions to reduce unauthorized use of their facilities. However, Qwest does not warrant or guarantee that its recommendations will prevent all unauthorized use, and the subscriber is responsible for controlling access to, and use of, its own telephone facilities. Non-recurring charges are payable when the service for which they are applied has been made available. If an entity other than Qwest (e.g., another carrier or a supplier) imposes charges on Qwest, in addition to its own internal costs, those charges will be passed on to the customer. Recurring charges which are fixed in amount and not dependent on usage are billed in advance. Except for usage charges the rate or volume discount level applicable to a customer for a particular service or services shall be the rate or volume discount level in effect at the end of the monthly billing period applicable to the customer for the particular service or services. The Customer agrees to pay the Carrier for all charges billed as a result of any use of the customer's authorization codes(s), whether such use is by customer or by a third party in connection with a lost, stolen or misappropriated authorization code, or otherwise. It is the customer's responsibility to inform Qwest that an authorization code(s) has been stolen or lost.

Service is provided and billed on a monthly (30 day) basis, beginning on the date that service becomes effective.

Payment will be due upon receipt. Interest may be applied in accordance with Qwest Communications Company, LCC standard credit policy to any unpaid amount commencing thirty (30) days after the statement date.

If a customer accumulates more than \$500.00 of unpaid disputed or undisputed Qwest 800) Service charges, the Qwest Resp. Org. reserves the right not to honor that customer's request for a Resp. Org. change until such dispute is resolved or undisputed charges are paid in full.

**2.6 PAYMENT ARRANGEMENTS (Cont'd)**

In the event the company incurs fees or expenses, including attorney's fees in collecting or attempting to collect any charges owed the company, the customer will be liable to the Company for the payment of all such fees and expenses reasonably incurred.

Qwest's bills are payable upon receipt, unless Qwest indicates on the invoice or a billing insert that the sum shown as due need not be paid, because of the smallness of the amount, until the balance reaches some specified amount; or Qwest may deal with customers whose accounts show very small balances by withholding the issuance of an invoice until the amount due from the customer reaches a level which, in Qwest's sole discretion, is deemed large enough to justify initiating the billing and collection process; or Qwest may invoice low usage customers every other month unless a customer invoiced in such a manner requests monthly billing. When a bill is issued, amounts not paid within 30 days after the date of invoice will be considered past due. If Qwest becomes concerned at any time about the ability of a customer to pay its bills, Qwest, in its sole discretion, may require that customer pay its bill within a specified number of days and to make such payments in cash or the equivalent of cash.

Applicants for service or existing customers whose financial condition is not acceptable to Qwest, or is not a matter of general knowledge, may be required at any time to provide Qwest a security deposit as a condition of service. For residential customers, the deposit will be in cash or the equivalent of cash, up to an amount equal to the applicable installation charges, if any, and/or up to three months estimated charges based upon Qwest's experience with residential customers whose service has been discontinued for non-payment. For other customers, the deposit requested will be in cash or the equivalent of cash, up to an amount equal to the applicable installation charges, if any, and/or up to three month's actual or estimated usage charges for service to be provided. Any applicant or customer may also be required, at any time, whether before or after the commencement of service, to provide such other assurances of, or security for, the payment of Qwest's charges for its use of Qwest services as Qwest may deem necessary including, without limitation, advance payments for service, third party guarantees of payment, pledges or other grants of security interest in the customers assets, and similar arrangements. The required deposit or other security may be increased or decreased by Qwest as it deems appropriate in light of changing conditions and customers' usage pattern. In addition, Qwest shall be entitled to require such an applicant or customer to pay all its bills within a specified period of time, and to make such payments in cash or the equivalent of cash. In the case of a cash deposit, simple interest at the rate of six percent (6%) annually will be paid for the period during which the deposit is held by Qwest, unless a different rate has been established by the appropriate legal authority in the jurisdiction in which the Qwest service in question is provided.

**2.6 PAYMENT ARRANGEMENTS (Cont'd)**

At Qwest's option, such deposit may be refunded to the customers account at any time. Qwest also reserves the right to cease accepting and processing service orders after it has requested a security deposit and prior to the customer's compliance with this request.

For the purpose of billing, the start of service date is the day of acceptance by the customer of Qwest's service. The end of service date is the last day of the minimum notification period as described above.

If a customer does not give Qwest written notice of a dispute within sixty (60) days from the date the invoice was rendered, such invoice shall be deemed to be correct and binding on the customer.

The charges set forth in this tariff contemplate installations made in normal locations and under normal working conditions. Any installations to be made under other circumstances are subject to additional charges.

Promotional and other credits offered by Qwest in the marketing of its service cannot be assigned, but must be used by the person to whom they were offered and who earned them in strict accordance with the terms of the offers. In the event that a customer has been awarded a promotional credit for subscribing to Qwest and does not use the service within 12 months following the date of the customer's service order, Qwest may cancel the credit from the customers account unless otherwise stated in the specific promotion.

All charges for service are exclusive of applicable federal, state, and local taxes, and tax related surcharges.

If a customer whose account has been closed has a credit balance showing, Qwest will transfer the credit to another account of the customer, if there is one, or will mail a check for the balance to the customer if it believes it has a valid and current address. If Qwest is not certain that it has a valid and current address, it will include a notice with the final invoice, which will be mailed to the customers last known address, asking the customer to verify the address so that it can make a refund, or it will write to the customer at that address and request verification. Such verification can be made by calling a designated telephone number or by writing to a specified address. Upon receiving verification, a check for the balance will be mailed. If the final invoice or the notification letter is returned by the post office as undeliverable, or if no response is received within thirty days of mailing, Qwest at its option may begin applying a closed account maintenance charge of \$2.50 per month in the second monthly billing period following the month in which the account was closed, and will continue to apply that charge until the customer requests a refund in writing or the balance is exhausted.

From time to time, Qwest will grant credits against usage or recurring monthly charges in an amount not to exceed \$1,000.00 per customer or account, per monthly billing period, whenever the company determines, in its sole discretion, that such a credit is warranted due to considerations or disputes involving the delivery of past service to the customer or account receiving the credit.

In lieu of the customer receiving applicable volume discounts and/or promotional credits on a monthly invoice, Qwest may, in its sole discretion, utilize other forms of payment.

In the event payment is made by check and the customers check is not honored by the institution on which it was drawn, Qwest will impose, and the customer will be required to pay, a \$35.00 fee, in addition to other tariff, legal, and equitable remedies available to Qwest.

If Qwest disconnects a customer's Qwest service for non-payment of past due amounts, the customer's service will remain disconnected until such time as Qwest receives payment for all past due amounts and confirms the availability of sufficient funds to satisfy the amount of payment.

A surcharge will be imposed on all customer's charges for outbound service originating at, or inbound service terminating at, addresses in states which levy, or assert a claim of right to levy: (i) a gross receipts tax on Qwest's operations in any such state; or, (ii) a tax on interstate access charges incurred by Qwest for access to telephone exchanges in that state; or, (iii) an ad valorem tax on Qwest's interstate property located in that state.<sup>1</sup> This surcharge is based, respectively, on Qwest's: (a) gross receipts or revenues in that state; and/or, (b) payment of interstate access charges in that state; and/or, (c) property located in that state and used by Qwest to provide interstate service. The surcharge for (c) is derived by using the ratio of interstate revenue in that state to total revenue, multiplied by total ad valorem taxes imposed during the current calendar year and are listed below. The surcharge will be shown as a separate line item on the customer's invoice.
