RE: 2013 Annual Filing Short Form Revision Errata Filing

On May 17, 2013, BellSouth Telecommunications, LLC (BellSouth) submitted a letter filing to provide revised exogenous cost changes for each basket of services in preparation for the 2013 Annual Tariff Filing to be submitted on June 17, 2013. This errata letter filing revises the May 17 filing, and it includes the following modification.

- Revised exogenous amount levels to reflect the correct allocation between Carrier Common Line and Special Access.

This letter is filed in compliance with Order DA 13-789, In the Matter of Material to be Filed in Support of 2013 Annual Access Tariff Filings, released April 19, 2013, and Order DA 13-553, In the Matter of July 2, 2013 Annual Access Charge Tariff Filings, (2013 TRP Order) released March 26, 2013.

The purpose of this letter, sent on behalf of BellSouth is to provide revised Price Cap Indices (PCIs) for each basket of service, as outlined in the attached Description and Justification and Tariff Review Plan (TRP), which are scheduled to become effective on July 1, 2013.

In accordance with Section 61.14, this letter filing and associated attachments are being filed electronically today via the Federal Communications Commission's Electronic Tariff Filing System (ETFS) in compliance with the electronic filing procedures.
