ACS Companies ("ACS") hereby requests waiver of Sections 61.58 and 61.59 of the Commission's rules in order to withdraw tariff revisions filed under Transmittal No. 24 on May 17, 2013, and re-file the tariff material contained in that Transmittal under Transmittal No. 25 with the correct notice period.

ACS inadvertently filed Transmittal No. 24 incorrectly on a 7 days notice under Section 204(a)(3). Transmittal No. 24 should have been filed on a 15 days notice under Section 204(a)(3) as the tariff revision does not propose any rate decreases. The proposed revision is to accurately reflect the current name of the issuing carriers in the FCC No. 1 tariff as they have changed from being Incorporated ("Inc.") to becoming a Limited Liability Company ("LLC").
