This filing is being made by Olsen Thielen & Co., Ltd. on behalf of: Mankato Citizens Telephone Company, Mid-Communications, Inc and Heartland Telecommunications Company of Iowa.

On July 2, 2013, Mankato Citizens Telephone Company, Mid-Communications, Inc., and Heartland Telecommunications Company of Iowa will no longer be issuing carriers of the ICORE, INC. TARIFF F.C.C. NO. 2 ACCESS SERVICE and will become issuing carriers of a new OLSEN THIELEN & CO., LTD. TARIFF F.C.C. NO. 2 Access Service Tariff.

Since the above three mentioned telephone companies file their cost support pursuant to Section 61.39 of the Commission's rules, his new tariff will refer to NECA's Tariff FCC No. 5 for its terms and conditions, but will contain rates specific to the above mentioned three telephone companies.

Pursuant to §§61.151 through 61.153 of the Commission's rules, Olsen Thielen & Co., Ltd. requests special permission under which the Commission would grant a waiver, to the extent required, of §§61.52(a)(1), and 61.54(b)(2) of the Commission's rules in connection with the issuance of the new tariff.

Olsen Thielen & Co., Ltd. requests waiver of §61.52(a)(1) to permit it to place the name "Olsen Thielen & Co., Ltd." on each tariff sheet and waiver of §61.54(b)(2) to permit it to place the name " Olsen Thielen & Co., Ltd. " on the title page of the tariff. Olsen Thielen & Co., Ltd. intends to include the exact legal names of the carriers covered by the OLSEN THIELEN & CO., LTD. TARIFF F.C.C. NO. 2 Access Service Tariff in the "Issuing Carriers" section of the new tariff.
