5.2 End User Common Line Charge

The Company recovers some of the costs of the telephone line or trunk connected to the customer's premises through a monthly charge called the End User Access Charge. The End User Access Charge is a monthly, flat-rated charge assessed to end users for each local exchange service line or trunk. The End User Access Charge will be based on a monthly snapshot of end user accounts. No fractional debits or credits will be created.

SECTION 5 - MISCELLANEOUS SERVICES AND CHARGES, (CONT'D)**5.4 Federal Universal Service Fee**

In connection with the FCC's Universal Service Orders, ACN will pay a percentage of its retail revenues to support the Universal Service Fund (USF). ACN will pass-through the USF assessment to its customers by assessing a charge applicable against all retail interstate and international charges, including usage and non-usage charges. This surcharge is in addition to standard usage charges and any applicable service charges and surcharges associated with the Company's service. The Company's Universal Service Fee factor will match the relevant quarterly Universal Service Contribution Factor approved by the FCC rounded up to the nearest tenth of a percent.
