6.3 Regulatory Compliance Recovery Surcharge

In connection with the Company's ongoing regulatory and compliance obligations, including, but not limited to, the Universal Service Fund, TRS, and the Federal Regulatory Fee, the Company assesses a monthly, flat-rated Regulatory Compliance Recovery Surcharge (RCRS) to end users for each local exchange service line, trunk or Remote Call Forwarding (RCF) arrangement. This surcharge is in addition to standard monthly recurring, nonrecurring, or usage charges and any other applicable surcharges associated with the Company's service. The RCRS is based on a monthly snapshot of end user accounts. No fractional debits or credits will be created.
