SECTION 6. SWITCHED ACCESS SERVICE (Cont.)6.1 General (Cont.)6.1.2 Rate Categories (Cont.)(B) Local Transport (Cont.)(5) Tandem Switching

The Tandem Switching rate recovers a portion of the costs of switching traffic through an access tandem. The Tandem Switching rate specified in Section 10 following is applied on a per access minute per tandem basis for all originating and all terminating minutes of use switched at the tandem.

(6) Access Tandem Trunk Port

An access tandem trunk port (ATTP) is provided for each Feature Group trunk terminated on the serving wire center side of the access tandem when the customer has requested tandem routing. The ATTP rate is applicable monthly on a DS0 level trunk basis.

(7) Multiplexing

DS1 to Voice Grade Multiplexing charges apply when a High Capacity DS1 Direct Trunked Facility is connected with Voice Grade Direct Trunked Transport. However, a DS1 to Voice Grade Multiplexing Charge does not apply when High Capacity DS1 Direct Trunked Transport is terminated at an electronic end office, and only Switched Access Service is provided over the DS1 facility (i.e., Voice Grade Special Access channels are not derived). The DS1 to Voice Grade multiplexer will convert a 1.544 Mbps channel to 24 Voice Grade channels.

(8) Common Trunk Port

(N)

The Common Trunk Port provides for the use of shared end office trunk ports for the termination of common transport trunks for tandem or end office routed traffic.

(9) Dedicated Trunk Port

(N)

The Dedicated Trunk Port provides for termination of a dedicated trunk as a trunk side arrangement to an end office or provides access into the access tandem at the serving wire center side of the switch.
